1 **Be it enacted by the People of the State of Maine as follows:**

2 **Sec. 1. 29-A MRSA §1411** is enacted to read:

3 **§1411. Prohibition against participation in a national identification card system**

4 The State may not participate in a national identification card system and the
5 Secretary of State may not amend the procedures for applying for a driver's license or
6 nondriver identification card under this chapter in a manner designed to conform to a
7 national identification card system.

8 **SUMMARY**

9 The bill prohibits the State from participating in a national identification card system.
