8 HOUSE AMENDMENT "#" to H.P. 914, L.D. 1296, Bill, "An Act To Amend 9 Certain Harness Racing Laws"

10 Amend the bill by inserting after the title and before the enacting clause the 11 following:

12 'Emergency preamble. Whereas, acts and resolves of the Legislature do not
 13 become effective until 90 days after adjournment unless enacted as emergencies; and

14 **Whereas,** appropriate penalties for violations of the harness racing statutes are 15 essential to maintaining the integrity of the industry; and

16 Whereas, most racing occurs in the summer months; and

Whereas, in the judgment of the Legislature, these facts create an emergency within
the meaning of the Constitution of Maine and require the following legislation as
immediately necessary for the preservation of the public peace, health and safety; now,
therefore,'

Amend the bill in section 1 in §280 in the first line (page 1, line 4 in L.D.) by striking out the following: "<u>§280. Use of drugs or appliance; veterinarian</u>" and inserting the following: '<u>§280. Use of drugs or appliances; prearrangement of results;</u> <u>veterinarian</u>'

Amend the bill in section 1 in §280 in subsection 2 in the 2nd line (page 1, line 13 in L.D.) by striking out the following: "connivance" and inserting the following: 'collusion'

27 Amend the bill by adding before the summary the following:

28 'Emergency clause. In view of the emergency cited in the preamble, this
 29 legislation takes effect when approved.'

#### 30 SUMMARY

This amendment, like Committee Amendment "A", makes the bill an emergency and expands a headnote but also clarifies a term.

### **Fiscal Note**

Minor cost increase - General Fund Removes previously indicated correctional and judicial impact

#### **Fiscal Detail and Notes**

The bill had indicated it was establishing a Class C crime and the fiscal note indicated that but did not account for the fact that the affected violations were already in statute with penalties similar to those of Class C but had not been labeled as Class C. Therefore, the fiscal impact of labeling is negligible and this corrects the fiscal note to indicate the only impact left is a minor cost increase to the Department of the Attorney General which can be absorbed utilizing existing budgeted resources.
