An Act To Increase Civil Penalties for Violations of Fire Code Laws Applicable to Fire Escape Installment and Maintenance

### 1 Be it enacted by the People of the State of Maine as follows:

Sec. 1. 25 MRSA §2453, as amended by PL 2001, c. 31, §1, is repealed and the
following enacted in its place:

### 4 §2453. Fire escapes; appeals

5 1. Certain buildings; more than one way of egress. Each story above the first 6 story of a building used as a schoolhouse, orphan asylum, hospital for the mentally ill, 7 reformatory, opera house, hall for public assemblies, hotel or tenement house occupied by 8 more than 2 families or store in which more than 10 persons are employed above the first 9 story must be provided with more than one way of egress, by stairways on the inside or 10 fire escapes on the outside of such a building. The stairways and fire escapes must be 11 constructed, in a number or of a size and in a location so as to give reasonably safe, 12 adequate and convenient means of exit, in view of the number of persons who may need 13 to use the stairway or fire escape, must at all times be kept free from obstruction and must 14 be accessible from each room in each story above the first story.

15 2. Apartment building; single exit permitted with sprinkler system. Any 16 apartment building of 3 stories or less in its entirety is permitted to have a single exit 17 under the condition that the building is protected throughout by an approved automatic 18 sprinkler system and meets the requirements of the applicable chapter of the National Fire 19 Protection Association Life Safety Code 101 and every sleeping room has a second 20 means of escape.

3. Commissioner approval of fire escape or alarm system. An individual,
 partnership or corporation may not offer for sale in this State any type of fire escape
 device or fire alarm system without first securing approval of the Commissioner of Public
 Safety.

25 4. Order of the commissioner. A person or corporation aggrieved by an order of the Commissioner of Public Safety issued under this section may appeal to the Superior 26 27 Court by filing within 30 days from the effective date of the order a complaint. The court shall fix a time and place of hearing and cause notice of the time and place to be given to 28 29 the commissioner. After the hearing, the court may affirm or reverse in full or in part an 30 order of the commissioner, and the decision of the court is final. If the commissioner, in the interest of public safety and because the commissioner determines there is immediate 31 32 danger, forbids the use of a building for any public purpose until satisfactory compliance 33 with the commissioner's order, the order becomes effective-immediately and the filing of 34 the complaint may not operate as a stay.

35 <u>5. Violation.</u> A violation of this section by a person, firm or organization is a civil
 36 violation punishable by a fine of not more than \$500.

#### SUMMARY

2 This bill provides that a person, firm or organization that violates the law pertaining 3 to the installment and maintenance of fire escapes commits a civil violation for which a 4 fine of not more than \$500 may be assessed.
