Amend the amendment in section 3 in §2847-M in subsection 3 in the first line (page
2, line 23 in amendment) by striking out the following: "The" and inserting the following:
'Notwithstanding Title 5, section 285, subsection 1, paragraph G, except for any policy,
contract or certificate between an insurer and the state employee health plan established
in Title 5, section 285, the'

Amend the amendment in section 4 in §4253 in subsection 3 in the first line (page 3,
line 6 in amendment) by striking out the following: "The" and inserting the following:
'Notwithstanding Title 5, section 285, subsection 1, paragraph G, except for any policy,
contract or certificate between an insurer and the state employee health plan established
in Title 5, section 285, the'

Amend the amendment by striking out all of section 6.

SUMMARY

This amendment clarifies that the coverage requirements established in the
amendment do not apply for any state employee health plan policy, contract or certificate
on or after the effective date of those requirements. It also strikes the appropriations and
allocations section.
