9 COMMITTEE AMENDMENT " \mathcal{A} " to S.P. 574, L.D. 1630, Bill, "An Act To 10 Address an Inequity in the Judicial Retirement System"

11 Amend the bill by striking out everything after the enacting clause and before the 12 summary and inserting the following:

13 'Sec. 1. 4 MRSA §1201, sub-§9, as amended by PL 1983, c. 863, Pt. B, §§8 and
45, is further amended to read:

15 9. Earnable compensation. "Earnable compensation" means the annual salary as a 16 judge. Any money paid by the State under an annuity contract for the future benefit of a 17 judge shall must be considered part of the judge's earnable compensation. The earnable 18 compensation of a member retired with a disability retirement allowance under section 19 1353 shall must be assumed, for the purposes of determining benefits under this chapter, 20 to be continued after his the member's date of termination of service at the same rate as 21 received immediately prior thereto, subject to the same percentage adjustments, if any, 22 that may apply to the amount of retirement allowance of the beneficiary under section 23 1358. Beginning July 1, 2003, earnable compensation for a judge includes the salary that 24 would have been paid for a judge in the given year if the cost-of-living adjustments in 25 fiscal year 2003-04 and fiscal year 2004-05 had been funded.

26 Sec. 2. 4 MRSA §1304, as amended by PL 1993, c. 410, Pt. L, §4, is further 27 amended to read:

28 §1304. Employees' contributions

On and after July 1, 1993, each member in service shall contribute at a rate of 7.65% of earnable compensation, except that judges whose earnable compensation includes imputed cost-of-living adjustments under section 1201, subsection 9, shall contribute based on the compensation actually paid.

33 Sec. 3. Application. This Act applies to judges who retire on or after the effective

14 SUMMARY

15 This amendment replaces the bill.

This amendment addresses the fact that cost-of-living adjustments were not provided to judges in fiscal year 2003-04 and fiscal year 2004-05. This amendment requires the calculation of compensation for retirement benefits to consider the judges' compensation as including the cost-of-living adjustments. The unfunded liability costs associated with this legislation will be paid from the surplus in the Maine Judicial Retirement System. The employee contribution is based on the compensation actually paid and not on the imputed cost-of-living adjustments.

- 23 This amendment applies to judges who retire on or after the effective date of this Act.
- 24 This amendment also adds an appropriations and allocations section to the bill.

Fiscal Detail and Notes

This bill includes ongoing General Fund appropriations of \$223,984 in fiscal year 2007-08 and \$232,943 in fiscal year 2008-09 to the Judicial Department for the increase in the employers' retirement contributions due to the provision that allows judges to include as earnable compensation imputed salary based upon cost-of-living adjustments that were not funded in 2003 and 2004.

This fiscal note assumes that the one-time cost of \$1,138,653 to the Maine State Retirement System for the unfunded liability cost of the provision described above will be paid from surplus funds available in the Judicial Retirement System. As of the June 30, 2006 valuation, the Judicial Retirement System had a surplus in the amount of \$1,248,240. The surplus funds are currently used to reduce the overall employer contribution rate.
