13	'Sec. 1. 7 MRSA §712, sub-§8-A is enacted to read:
14 15 16	8-A. Home-based manufacturer of pet food. "Home-based manufacturer of perfood" means a person who manufactures 10 or fewer product names in that person's home and sells the products directly to consumers."
17 18 19	Amend the bill in section 1 in §714 in subsection 1 in the 6th and 7th lines (page 1 lines 10 and 11 in L.D.) by striking out the following: "producing 10 or fewer producing names and selling directly to consumers"
20 21 22	Amend the bill in section 1 in §714 in subsection 4 in the 4th line (page 1, line 34 in L.D.) by striking out the following: "producing 10 or fewer product names and selling directly to consumers"
23 24	Amend the bill by relettering or renumbering any nonconsecutive Part letter o section number to read consecutively.
25	SUMMARY
26 27	This amendment enacts a definition of "home-based manufacturer of pet food" and makes changes in the bill to reflect the presence of the definition.

Beginning in fiscal year 2007-08, reducing the registration fees for home-based manufacturers of pet foods will reduce annual General Fund and dedicated revenue collected by the Department of Agriculture, Food and Rural Resources by \$1,850 for each revenue source.
