An Act Regarding Street Rods and Custom Vehicles

1	Be it enacted by the People of the State of Maine as follows:
2 3	Sec. 1. 29-A MRSA §101, sub-§19-A, as enacted by PL 2005, c. 321, §1 and affected by §6, is repealed and the following enacted in its place:
4	19-A. Custom vehicle. "Custom vehicle" means:
5	A. A motor vehicle that is:
6	(1) At least 25 years old;
7 8	(2) Maintained primarily for use in exhibitions, club activities, parades and other functions of public interest; and
9 10	(3) Not used as its owner's primary mode of transportation of passengers or goods; or
11	B. A motor vehicle that:
12	(1) Was manufactured to resemble a motor vehicle that is at least 25 years old;
13 14	(2) Has been altered from the manufacturer's original design or has a body constructed from nonoriginal material;
15 16	(3) Is maintained primarily for use in exhibitions, club activities, parades and other functions of public interest; and
17 18	(4) Is not used as its owner's primary mode of transportation of passengers or goods.

The Secretary of State may issue registration plates for antique autos, custom vehicles, horseless carriages, street rods or antique motorcycles. These plates must bear the inscription "Maine" and the inscription "Antique Auto," "Custom Vehicle," "Horseless Carriage" or "Street Rod" or, for antique motorcycles, the inscription "Antique." Only a motor vehicle that is maintained primarily for use in exhibitions, club activities, parades and other functions of public interest and is not used as its owner's primary mode of transportation of passengers or goods may be registered pursuant to this section.

36 Sec. 4. 29-A MRSA §457, sub-§3, as enacted by PL 1993, c. 683, Pt. A, §2 and 37 affected by Pt. B, §5, is amended to read: 1 **3.** Contemporary plates. An owner of an antique auto, <u>custom vehicle</u>, horseless 2 carriage, street rod or antique motorcycle may use registration plates that were issued in 3 the same year the antique vehicle was manufactured, as long as the motor vehicle:

4 A. Is over 25 years old;

SUMMARY

This bill amends the definitions of "custom vehicle" and "street rod" in the laws 20 governing motor vehicles to provide that a custom vehicle or street rod be maintained 21 primarily for use in exhibitions, club activities, parades and other functions of public 22 interest and not used as its owner's primary mode of transportation of passengers or 23 goods. It amends the definition of "custom vehicle" to provide that such a vehicle be at 24 25 least 25 years old or manufactured to resemble a motor vehicle that is at least 25 years old rather than at least 30 years old or manufactured to resemble a motor vehicle that is at 26 least 30 years old as under current law and to eliminate the requirement that such a 27 28 vehicle be of a model year after 1948 or manufactured to resemble a motor vehicle of a model year after 1948. It provides that only a motor vehicle that is maintained primarily 29 for use in exhibitions, club activities, parades and other functions of public interest and is 30 not used as its owner's primary mode of transportation of passengers or goods may be 31 32 registered pursuant to the Maine Revised Statutes, Title 29-A, section 457. It provides that an owner of a custom vehicle may use contemporary plates on that vehicle. It 33 eliminates an alternative method of registering custom vehicles and clarifies that custom 34 vehicles, horseless carriages, street rods and antique motorcycles are exempt from motor 35 36 vehicle inspection requirements.
