An Act To Amend the Laws Relating to Notaries Public

## 1 Be it enacted by the People of the State of Maine as follows: 2 Sec. 1. 5 MRSA §82, as amended by PL 1997, c. 712, §3, is repealed and the 3 following enacted in its place: 4 §82. Appointment of notaries public; term of appointment; additional requirements 5 for resident of adjoining state; term renewal of commissions 6 1. Appointment and renewal. The Secretary of State may appoint and renew a 7 commission of a notary public who: 8 A. Is 18 years of age or older at the time of appointment; 9 B. Is a resident of this State at the time of appointment or is a resident of an adjacent 10 state, is regularly employed or carries on a trade or business in this State at the time 11 of appointment and submits an affidavit as described in subsection 2: 12 C. Demonstrates proficiency in the English language at the time of appointment; 13 D. Has not had a notary commission revoked or suspended for official misconduct in 14 this State or any other jurisdiction during the 5-year period preceding the date of 15 application; 16 E. Has not been convicted of a crime punishable by imprisonment for one year or 17 more, or of a lesser offense incompatible with the duties of a notary public as defined 18 by rule by the Secretary of State during the 10-year period preceding the date of application for a new or renewed commission; and 19 20 F. Has satisfactorily completed a written examination prescribed by the Secretary of State to determine the fitness of the person to exercise the functions of the office of 21 22 notary public. 23 2. Affidavit. An applicant for appointment as a notary public who resides in an adjoining state must submit to the Secretary of State with the application an affidavit as 24 25 follows: 26 A. If the applicant is not self-employed, an affidavit from the applicant's employer 27 stating that: 28 (1) The employer is licensed, authorized or registered to do business in this 29 State: and 30 (2) The employer regularly employs the applicant at an office, business or facility that is located in this State; or 31 32 B. If the applicant is self-employed, an affidavit from the applicant stating that: 33 (1) The applicant is licensed, authorized or registered to do business in this State; 34 and 35 (2) The applicant has an office, business or facility that is located in this State.

36 The affidavit required by this subsection must be in a form and format as defined by rule
 37 by the Secretary of State.

- 1 <u>3. Written examination.</u> The Secretary of State shall:
- 2 A. Make the written examination required by subsection 1 a part of the application
- 3 for a new commission or the renewal of a commission; and
- B. Furnish study materials relating to the written examination to an applicant without
   charge upon request of the applicant.
- 6 <u>4. Term.</u> A person appointed as a notary public serves the following term of office:
- 7 <u>A. For a resident of this State, a term of 7 years; or</u>
- 8 B. For a resident of an adjacent state, a term of 4 years.

9 5. Power extends to all counties. A person appointed as a notary public may
 10 exercise that person's power and duties in any and all counties in this State.

6. Rules. The Secretary of State shall adopt rules relating to the appointment and renewal of commissions of notaries public. The rules must include criteria and a procedure to be applied by the Secretary of State in appointment and renewal. The Secretary of State may not refuse to appoint or renew solely because the applicant lives or works in a specific geographic area or because of political party affiliation. Rules adopted pursuant to this subsection are routine technical rules as defined in chapter 375, subchapter 2-A.

7. Notice of expiration of commission. The Secretary of State shall provide notice
 of the expiration of a commission to a notary public 30 days prior to the expiration date.
 The notice must be in a form or format as determined by rule by the Secretary of State.
 Failure to receive a notice does not affect the expiration date of a commission.

8. Investigation of complaints. The Secretary of State shall investigate or cause to be investigated all complaints concerning improper or illegal notarial acts performed by notaries public made on the Secretary of State's own motion or on written complaint filed with the Secretary of State.

- 27 §82-B. Notary Public Review Board
- Board created. The Notary Public Review Board, as established by Title 5,
   section 12004-G, subsection 31-C and referred to in this section as "the board," is created
   to review violations of law by notaries public and complaints concerning notaries public
   made pursuant to section 82, subsection 8.
- 32 **2. Membership.** The board consists of 5 members as follows:
- 33 <u>A. Two members selected from a list of members provided by the board of directors</u>
- 34 of a statewide group dedicated to the education of notaries in this State appointed by
- 35 <u>the Governor;</u>
- B. One member who has been a notary public for less than 7 years, appointed by the
   Governor;

1 2	C. One member who has been a notary public for more than 7 years, appointed by the Governor; and
3 4	D. One member who has knowledge of notarial law and practices who is employed by the Secretary of State, appointed by the Secretary of State.
5 6	3. Chair. The member of the board appointed by the Secretary of State is the chair of the board. The chair shall:
7	A. Act as the presiding officer in all matters that come before the board;
8	B. Make preliminary rulings on discovery and other questions;
9	C. Participate fully in board deliberations; and
10	D. Vote on the merits of complaints that come before the board.
11 12 13	4. Terms. Except for the member appointed by the Secretary of State, members of the board serve 3-year terms. The member appointed by the Secretary of State serves a the pleasure of the Secretary of State.
14	5. Vacancy. Any vacancy on the board must be filled pursuant to subsection 2.
15 16 17	6. Reimbursement for expenses. Members of the board may be reimbursed by the Secretary of State for reasonable and necessary expenses incurred in carrying out their duties.
18 19 20 21 22 23 24 25	7. Review of complaints. The board shall review complaints against notaries public pursuant to section 82, subsection 8. The board may hold a hearing as part of its review to determine whether grounds exist for denial of commission, suspension of commission revocation of commission or renewal of commission or other action necessary to the fulfillment of the Secretary of State's responsibility under the laws of this State. The board may recommend to the Secretary of State that a notary public's commission be denied, suspended, revoked or not renewed or any other action that the board determinent to be appropriate.

The board has the power reasonably necessary to perform the dutien required of the Secretary of State by this section, including the power to make rules no inconsistent with this section. 35 terms. Notwithstanding the Maine Revised Statutes, Title 5, section 82-B, subsection 4,

1 for the initial appointments made by the Governor to the Notary Public Review Board, 2 the Governor shall appoint 2 members for 3-year terms, one member for a 2-year term

3 and one member for a 1-year term.

## SUMMARY

5 This bill repeals and replaces the current law governing the appointment and renewal 6 of commissions of notaries public. It includes a comprehensive process and criteria to 7 evaluate a candidate for the office of notary public. It establishes a process for a resident 8 of an adjoining state to be considered for the office of notary public.

9 The bill creates a review board to review a violation of notary law or a complaint 10 concerning a notary public and provides a mechanism to deal with a violation or 11 complaint.
