### An Act To Provide Taxpayer Relief

1 **Be it enacted by the People of the State of Maine as follows:**

2 **Sec. 1. 5 MRSA §1507, next to last ¶**, as amended by PL 2005, c. 519, Pt. VV,  
3 §1, is repealed.

4 **Sec. 2. 5 MRSA §1511**, as amended by PL 2005, c. 519, Pt. VV, §2, is repealed.

5 **Sec. 3. 5 MRSA §1522** is enacted to read:

6 **§1522. Maine Budget Stabilization Fund**

7 **1. Establishment.** The Maine Budget Stabilization Fund, referred to in this section  
8 as "the fund," is established and must be administered for the purposes identified in this  
9 section.

10 **2. Transfers to fund; limits.** The fund may receive transfers by the State Controller  
11 of unappropriated surplus at the close of a fiscal year as provided in section 2045 and any  
12 other funds identified by law. The fund may not exceed 10% of the total General Fund  
13 revenues received in the immediately preceding fiscal year and may not lapse, but  
14 remains in a continuing carrying account to carry out the purposes of this section. The  
15 limit at the close of a fiscal year is based on the total General Fund revenues received in  
16 the fiscal year being closed.

17 **3. Use of fund.** The Legislature may authorize transfers, appropriations and  
18 allocations from the fund only to fund the costs of State Government up to the  
19 expenditure limit calculated under section 2044 in years when state revenues are less than  
20 the amount necessary to finance the level of expenditures permitted under section 2044.

21 **4. Investment of funds; proceeds.** The money in the fund may be invested as  
22 provided by law, with the earnings credited to the fund. At the close of every month  
23 during which the fund is at the 10% limitation described in subsection 2, the State  
24 Controller shall transfer the excess to the Tax Relief Reserve Fund established under  
25 section 2045.

26 **Sec. 4. 5 MRSA §1523** is enacted to read:

27 **§1523. Maine Highway Budget Stabilization Fund**

28 **1. Establishment.** The Maine Highway Budget Stabilization Fund, referred to in  
29 this section as "the fund," is established and must be administered for the purposes  
30 identified in this section.

31 **2. Transfers to fund; limits.** The fund may receive transfers by the State Controller  
32 of unallocated Highway Fund surplus at the close of a fiscal year as provided in section  
33 2046 and any other funds identified by law. The fund may not exceed 10% of the total  
34 Highway Fund revenues received in the immediately preceding fiscal year and may not  
35 lapse, but remains in a continuing carrying account to carry out the purposes of this  
36 section. The limit at the close of a fiscal year is based on the total Highway Fund  
37 revenues received in the fiscal year being closed.



1 1. Expenditure limitations. Annual state and local expenditures may not exceed the  
2 limits provided in this chapter unless authorized by the procedures specified in this  
3 chapter.

4 2. Revenue increases. An increase in revenue of the State may be adopted only as  
5 provided in section 2043.

6 3. Construction. It is the intent of the Legislature that this chapter be interpreted  
7 liberally to restrain excess growth of state and local government.

8 **§2042. Definitions**

9 As used in this chapter, unless the context otherwise indicates, the following terms  
10 have the following meanings.

11 1. Election officer. "Election officer" means:

12 A. In a statewide, county or municipal election, the municipal registrar of voters; or

13 B. In an election by the voters of a local district that is not a municipality, the official  
14 with responsibility for managing the list of voters of the local district.

15 2. Increase in revenue. "Increase in revenue" means any legislation, local  
16 ordinance or tax levy that causes a net gain in revenue and:

17 A. Enacts a new tax or fee;

18 B. Increases the rate or expands the base of an existing tax or fee;

19 C. Repeals or reduces any tax exemption, credit or refund; or

20 D. Extends an expiring tax or fee increase.

21 3. Inflation adjustment factor. "Inflation adjustment factor" means the increase in  
22 the Consumer Price Index for the most recently available calendar year as calculated by  
23 the United States Department of Labor, Bureau of Labor Statistics.

24 4. Local district. "Local district" means any county, municipality or school  
25 administrative unit.

26 5. Population adjustment factor. "Population adjustment factor" means the  
27 average annual percentage increase in population for the 3 most recent years for which  
28 data is available as determined annually by the Executive Department, State Planning  
29 Office statewide and for each municipality based on federal census estimates. The  
30 population adjustment factor may not be less than zero.

31 6. Revenue. "Revenue" means taxes and fees collected by the State or a local  
32 district pursuant to the statutes of the State, including those collected under Title 36, Part  
33 2. It includes money received from the sale of goods and services only to the extent that  
34 the receipts exceed the cost of providing the goods or services.

1 **§2043. Approval of revenue increases**

2 **1. Approval of increases.** The following forms of approval are required to adopt an  
3 increase in revenue:

4 **A. For an increase in revenue of the State:**

5 (1) The measure must be approved by a vote of 2/3 of all the members of each  
6 House of the Legislature; and

7 (2) Except as provided in subsection 2, the measure must be approved by a  
8 majority of the voters as described in subsection 3.

9 **B. For an increase in revenue of a local district the measure must be approved in the**  
10 **manner provided by Title 20-A, chapter 606-B for school administrative units, Title**  
11 **30-A, section 706-A for counties and Title 30-A, section 5721-A for municipalities.**

12 **2. Exceptions.** Voter approval under subsection 1, paragraph A, subparagraph (2) is  
13 not required if:

14 **A. Annual state revenue is less than annual payments on general obligation bonds,**  
15 **required payments related to pensions and final court judgments; or**

16 **B. The measure is an emergency tax and the provisions of section 2049 are followed.**

17 For the purposes of this subsection, "emergency" does not include economic conditions,  
18 revenue shortfalls or district salary or fringe benefits increases.

19 **3. Approval by voters; emergency approval.** The question of whether to adopt  
20 legislation to impose an increase in revenue of the State must be submitted to the voters  
21 for approval at the next general election as defined in Title 21-A, section 1. If the  
22 Legislature determines by a 2/3 vote that legislation to increase taxes or fees should take  
23 effect sooner than the next general election, the Legislature may provide for submission  
24 of the question to the voters at any regular or special election as defined in Title 21-A,  
25 section 1.

26 **4. Revenue estimates.** A measure submitted to the voters under subsection 3 must  
27 include an estimate of the amount to be raised by the measure for the first 4 fiscal years of  
28 its implementation.

29 **5. Notice.** At least 30 days before an election required under subsection 3, the  
30 election officer shall mail at the least cost a titled notice or set of notices addressed to  
31 "All Registered Voters" at each address of every active registered voter. Notices must  
32 include the following information and may not include any additional information:

33 **A. The election date, hours, ballot title and text and local election office address and**  
34 **telephone number;**

35 **B. For each proposed revenue increase, the estimated or actual total of fiscal year**  
36 **spending for the current year and each of the past 4 years and the overall percentage**  
37 **and dollar change; and**

1 C. For the first full fiscal year of each proposed revenue increase, estimates of the  
2 maximum dollar amount of each increase and of fiscal year spending without the  
3 increase.

4 Except by later voter approval, if an increase in revenue exceeds any estimate prepared  
5 under paragraph C for the same fiscal year, the tax increase is thereafter reduced in  
6 proportion to the amount of the excess, and the excess revenue that was collected must be  
7 refunded in the next fiscal year. Ballot questions for revenue increases must begin:  
8 "Shall (specify district) revenues be increased (amount of first or, if phased in, full fiscal  
9 year dollar increase) annually...?"

10 6. Costs. The State shall reimburse municipalities for the costs of any election under  
11 this section and providing the notice required under subsection 5 if the election provides  
12 for a state tax increase.

13 **§2044. Expenditure limitations**

14 1. State expenditure limitation. Beginning with the first fiscal year that begins  
15 after this section takes effect, the maximum annual percentage change in state fiscal year  
16 spending in the categories specified in this subsection equals the inflation adjustment  
17 factor plus the population adjustment factor and any increases attributable to measures  
18 approved under section 2043. This limitation must be calculated separately for the  
19 following categories:

20 A. General Fund;

21 B. Highway Fund; and

22 C. Other Special Revenue Funds, for which separate individual limitations must be  
23 applied.

24 2. Local expenditure limitation. Expenditure limits for local districts that are  
25 school administrative units are governed by Title 20-A, chapter 606-B; for local districts  
26 that are counties, by Title 30-A, section 706-A; and for local districts that are  
27 municipalities, by Title 30-A, section 5721-A.

28 3. Exceptions. The following may not be counted in calculating expenditure  
29 limitations under subsection 1:

30 A. Amounts returned to taxpayers as refunds of amounts exceeding the expenditure  
31 limitation in a prior year;

32 B. Amounts received from the Federal Government;

33 C. Amounts collected on behalf of another level of government;

34 D. Pension contributions by employees and pension fund earnings;

35 E. Pension and disability payments made to former government employees;

36 F. Amounts received as grants, gifts or donations that must be spent for purposes  
37 specified by the donor;

38 G. Amounts paid pursuant to a court award; or

1           H. Reserve transfers or expenditures.

2           4. Exceeding expenditure limitation. If state revenues are projected to exceed the  
3 expenditure limitations in this section, the amount of revenues exceeding the expenditure  
4 limitations may be spent if approved in the same manner as required for a revenue  
5 increase under section 2043.

6           §2045. Transfers and refund of unappropriated General Fund surplus

7           1. Fund created. The Tax Relief Reserve Fund, referred to in this section as "the  
8 fund," is created for the purposes set forth in this chapter. The fund may not lapse, but  
9 remains in a continuing carrying account to carry out the purposes of this section.

10           2. Transfer. At the close of each fiscal year, the State Controller shall identify the  
11 amount of General Fund unappropriated surplus and make the following transfers:

12           A. Eighty percent of the unappropriated surplus must be transferred to the fund; and

13           B. Twenty percent of the unappropriated surplus must be transferred to the Maine  
14 Budget Stabilization Fund established in section 1522.

15           3. Notification. By September 15th annually, the State Controller shall notify the  
16 Legislature and the State Tax Assessor of the amount in the fund as a result of the  
17 transfers required by subsection 2.

18           4. Refund through legislative action. If the amount in the fund exceeds  
19 \$25,000,000, the Legislature shall, by October 15th, enact legislation to provide for the  
20 refund to taxpayers of amounts in the fund. Refunds may take the form only of  
21 temporary or permanent broad-based tax credits, rebates or rate reductions.

22           5. Refund in case of legislative inaction. If the Legislature does not enact  
23 legislation by October 15th to provide refunds pursuant to subsection 4, then the State  
24 Controller shall, by October 30th, notify the State Tax Assessor of the amount in the  
25 fund. The State Tax Assessor shall calculate a one-time bonus personal exemption  
26 refund. The amount of the personal exemption refund must be calculated by dividing the  
27 amount in the fund identified by the State Controller under subsection 3 by the number of  
28 personal exemptions claimed on income tax returns filed for tax years beginning in the  
29 previous calendar year and rounded down to the nearest \$5 increment. The State Tax  
30 Assessor shall issue a refund by November 30th to a taxpayer who filed an income tax  
31 return by April 15th of the same calendar year based on the number of personal  
32 exemptions claimed on the taxpayer's return without regard to the taxpayer's tax liability  
33 for the year.

34           §2046. Transfers and refund of unallocated Highway Fund surplus

35           1. Fund created. The Highway Fund Reserve Fund, referred to in this section as  
36 "the fund," is created for the purposes set forth in this chapter.

37           2. Transfer. At the close of each fiscal year, the State Controller shall identify the  
38 amount of Highway Fund unallocated surplus and make the following transfers:



- 1       A. Eighty percent of the unallocated surplus must be transferred to the fund; and  
2       B. Twenty percent of the unallocated surplus must be transferred to the Maine  
3       Highway Budget Stabilization Fund established in section 1523.

4       3. Notification. By September 15th annually, the State Controller shall notify the  
5       Legislature of the amount in the fund as a result of the transfers required by subsection 2.

6       4. Refund through legislative action. If the amount in the fund exceeds 10% of  
7       Highway Fund expenditures for the previous fiscal year, the State Tax Assessor shall  
8       calculate, based on the amount in the fund, a proportional reduction in the taxes on motor  
9       fuels under Title 36, Part 5 to become effective the following January 1st and remain in  
10      effect for one calendar year.

11      §2047. Revenues of Other Special Revenue Funds accounts

12      By September 15th annually, each state agency that manages an Other Special  
13      Revenue Funds account shall submit an annual report to the Legislature identifying  
14      revenues received in the preceding fiscal year that exceed the expenditure limitation  
15      established in section 2044 and any other uncommitted revenues received during the  
16      previous fiscal year and proposing a plan for refunding the amount identified that exceeds  
17      10% of the previous fiscal year's expenditure.

18      §2048. Emergency taxes

19      1. Emergency taxes permitted; conditions. The State may impose emergency  
20      taxes only in accordance with this section:

21      A. The tax must be approved for a specified time period by a 2/3 majority of the  
22      members of each House of the Legislature;

23      B. Emergency tax revenue may be spent only after other available reserves are  
24      depleted and must be refunded 180 days after the emergency ends if not spent on the  
25      emergency; and

26      C. The tax must be submitted for approval by the voters at the next statewide  
27      election.

28      2. Absence of approval. If not approved by the voters as provided in this section,  
29      an emergency tax expires 30 days following the election.

30      **Sec. 9. 5 MRSA §13063-C, sub-§4, ¶B,** as amended by PL 2005, c. 2, Pt. A, §9  
31      and affected by §14, is further amended to read:

32      B. Notwithstanding section 1585, any balance remaining in the program after July  
33      31, 2007 must be transferred to the Maine Budget Stabilization Fund as established in  
34      section ~~1532~~ 1522.

35      **Sec. 10. 5 MRSA §17253, sub-§3,** as amended by PL 2005, c. 2, Pt. A, §10 and  
36      affected by §14, is further amended to read:

1           **3. Components of unfunded liability contribution.** The annual valuation report  
2 prepared by the actuary in accordance with section 17107 must include identification of  
3 the impact on the employer contribution rate of any excess General Fund revenues  
4 transferred to the Retirement Allowance Fund pursuant to section 1532.

5           **Sec. 11. 20-A MRSA §15671-A, sub-§3,** as amended by PL 2005, c. 2, Pt. D,  
6 §35 and affected by §§72 and 74 and c. 12, Pt. WW, §18, is further amended to read:

7           **3. Exceeding maximum local cost share expectations; separate article.**  
8 Beginning with the 2005-2006 school budget, the legislative body of a school  
9 administrative unit may adopt an additional local appropriation that exceeds the local cost  
10 share expectation established by section 15688, subsection 3-A, paragraph A only if that  
11 action is approved in a separate article by a vote of the school administrative unit's  
12 legislative body through the same process that by which the school budget is approved in  
13 that school administrative unit and in accordance with section 15690 and that action is  
14 approved by the voters at a referendum. If that additional appropriation causes the school  
15 administrative unit to exceed the maximum state and local spending target described in  
16 subsection 4, the requirements of subsection 5 apply.

17           **Sec. 12. 20-A MRSA §15671-A, sub-§5, ¶B,** as amended by PL 2005, c. 12, Pt.

10 the intent of the Legislature that the provisions of this Act supersede any conflicting  
11 provisions of private and special law relating to the determination of revenue, fees and  
12 expenditures.

13 **Sec. 21. Application.** This Act applies to fiscal years beginning on or after the  
14 effective date of this Act.

15 **SUMMARY**

16 This bill proposes to restrain the growth in state and local government by imposing  
17 expenditure limitations on state and local government and by requiring a procedure of  
18 voter approval of certain tax and fee increases.

19 Under this bill, growth in annual expenditures of the General Fund, the Highway  
20 Fund and Other Special Revenue Funds are limited according to increases in population  
21 and inflation. For the General Fund and Highway Fund budgets, revenues exceeding the  
22 expenditure limitation must be distributed by directing 20% of that excess to a budget  
23 stabilization fund and 80% of that excess to a tax relief fund. The budget stabilization  
24 funds may be used only in years when revenues are not sufficient to fund the level of  
25 expenditure permitted by the growth limits. The tax relief funds must be used to provide  
26 tax relief through refunds proportional to individual income tax personal exemptions  
27 claimed in the previous tax year or a decrease in motor fuels taxes. For state agencies  
28 that manage Other Special Revenue Funds, the managers of those funds must report  
29 excess surpluses to the Legislature with a plan for refund of those revenues.

30 State expenditure limits contained in this bill could be exceeded by a 2/3 vote of each  
31 House of the Legislature and approval by the voters. Local district expenditure limits  
32 could be exceeded by a majority vote of the voters of the local district.

33 Under this bill, an increase in state revenue would be possible only by a 2/3 vote of  
34 each House of the Legislature and the approval of the voters.
