# SENATE AMENDMENT

### SENATE AMENDMENT " $\mathcal{B}$ " to committee amendment "A" to S.P. 741, L.D. 1932

13. Termination of reorganization planning process. Notwithstanding any other 1 2 provision of this Part, if at any time the representatives of a school administrative unit participating on a reorganization planning committee determine by majority vote of those 3 representatives that it is not in the best interests of that school administrative unit to 4 5 continue the reorganization planning process, they may notify the reorganization planning committee and the governing body of the school administrative unit and request that the 6 7 governing body of the school administrative unit conduct a public hearing on whether or 8 not the school administrative unit should continue to participate in the reorganization 9 planning process. Following such a request, the governing body of the school administrative unit shall conduct a public hearing on the issue. Following the public 10 hearing, the governing body of the school administrative unit or, in the case of a 11 municipal school unit, the municipal officers may place a warrant article substantially as 12 follows on the ballot of a referendum in accordance with the referendum procedures 13 14 applicable to that school administrative unit:

#### SUMMARY

27 This amendment establishes a procedure by which a school administrative unit may withdraw from the school reorganization planning process. The procedure requires a 28 29 majority vote of the representatives of a school administrative unit on a reorganization planning committee followed by a public hearing and a referendum vote of the school 30 administrative unit on the question of whether the school administrative unit should opt 31 32 out of the school reorganization planning process.
