SENATE AMENDMENT "D" to COMMITTEE AMENDMENT "A" to S.P. 741,
L.D. 1932, Bill, "An Act To Amend the Laws Regarding School Funding"

Amend the amendment by inserting after the 2nd paragraph after the title the following:

'PART A'

Amend the amendment in section 14 in the first line (page 10, line 26 in amendment) by striking out the following: "Act" and inserting the following: 'Part'

Amend the amendment by inserting after section 14 the following:

'PART B

Sec. B-1. PL 2007, c. 240, Pt. XXXX, §36, sub-§11 is amended to read:

11. **Result of disapproval at January 2008 referendum.** A school administrative unit that rejects a proposed reorganization plan at the January 15, 2008 referendum or at a subsequent referendum on or before ~~November 4, 2008~~ January 15, 2009 may restart the process to form a regional school unit with the same or other school administrative units and may seek assistance from the Department of Education to prepare another reorganization plan.

A. Subsequent reorganization plans must meet the same requirements as for reorganization plans filed prior to the January 2008 referendum, except that the timelines are adjusted to reflect a July 1, 2009 reorganization date.

B. The penalties set forth in Title 20-A, section 15696 apply to any school administrative unit that fails to approve a reorganization plan on or before ~~November 4, 2008~~ January 15, 2009 and to implement that plan by July 1, 2009.

Sec. B-2. PL 2007, c. 240, Pt. XXXX, §36, sub-§12 is amended to read:

12. **Reformulation of SAD as RSU.** Not later than ~~December 1, 2008~~ February 15, 2009, the Commissioner of Education shall notify any school administrative district that has not voted to form a regional school unit on or before ~~November 4, 2008~~ January 15, 2009 that the school administrative district must be recreated as a regional school unit

1 under Title 20-A, chapter 103-A, effective July 1, 2009. Notwithstanding any other
2 provision of law, a school administrative district may be changed to a regional school unit
3 upon notice to the State Board of Education without dissolving the school administrative

7 **approved after January 15, 2008.** This section applies to a regional school unit that
8 is approved after January 15, 2008 and before ~~November 5, 2008~~ January 16, 2009.

9 **Sec. B-3. PL 2007, c. 240, Pt. XXXX, §43** is amended to read:

10 **Sec. XXXX-43. Operational date and transfer of authority.**

11 **1. Operational date.** A regional school unit board of directors becomes operational
12 on the date set by the State Board of Education as provided in the Maine Revised
13 Statutes, Title 20-A, chapter 103-A.

14 **2. Transfer of governing authority; regional school units approved prior to**
15 **January 16, 2008.** This subsection applies to regional school units approved prior to
16 January 16, 2008. The regional school unit board of directors, on the date established in
17 subsection 1, shall assume responsibility for the management and control of the public
18 schools and programs within the school administrative units in existence prior to July 1,
19 2008 that are within the regional school unit. Those school administrative units in
20 existence prior to July 1, 2008, on the date established in subsection 1, have no further
21 responsibility for the operation or control of the public schools and programs within the
22 school administrative unit except those pursuant to section 1481.

23 **3. Transfer of governing authority; regional school units approved after**
24 **January 15, 2008.** This subsection applies to regional school units approved after
25 January 15, 2008 and before ~~November 5, 2008~~ January 16, 2009. The regional school
26 unit board of directors, on the date established in subsection 1, shall assume responsibility
27 for the management and control of the public schools and programs within the school
28 administrative units in existence prior to July 1, 2009 that are within the regional school
29 unit. Those school administrative units in existence prior to July 1, 2009, on the date
30 established in subsection 1, have no further responsibility for the operation or control of
31 the public schools and programs within the school administrative unit except those
32 pursuant to section 1481.

33 **4. Transfer of school accounts.** Notwithstanding Title 20-A, section 15004 or any
34 charter of a municipal school unit, school administrative district or community school
35 district, the balance remaining in the school accounts of the former municipal school unit,
36 school administrative district or community school district within the regional school unit
37 must be paid to the treasurer of the regional school unit and verified through the annual
38 audit process pursuant to Title 20-A, chapter 221, subchapter 2. The balance from each of
39 the former municipal school unit, school administrative district or community school
40 district must be used to reduce that unit's or district's local contribution to the regional
41 school unit. Payment may be made in equal monthly installments during the
42 implementation year.

1 **5. Transfer of teachers and employees.** Except as limited by paragraph A, for
2 regional school units approved prior to January 16, 2008, all teachers and school
3 employees who are employed by a participating school administrative unit on June 30,
4 2008 must be transferred to and employed by the regional school unit as of July 1, 2008.
5 Except as limited by paragraph A, for regional school units approved after January 15,
6 2008 and before ~~November 5, 2008~~ January 16, 2009, all teachers and school employees
7 who are employed by participating school administrative units on June 30, 2009 must be
8 transferred and employed by the regional school unit as of July 1, 2009. Except as
9 limited by paragraph B, the regional school unit shall assume all of the legal obligations
10 and duties that the participating school administrative units owed to their employees,
11 including but not limited to those obligations and duties arising under federal law, state
12 law, collective bargaining agreements and individual employment contracts. It is the
13 intent of this Part to neither decrease nor increase the rights and benefits of transferred
14 employees or the employer. The regional school unit shall also maintain and honor any
15 agreements, contracts or policies regarding the rights and benefits of retirees and former
16 employees created by a participating school administrative unit that is dissolved as a
17 result of its inclusion within a regional school unit.

18 A. For regional school units approved prior to January 16, 2008, teachers or other
19 employees whose employment terminates by application of law or contract or by
20 action of a participating school administrative unit before July 1, 2008 may not be
21 transferred. For regional school units approved after January 15, 2008 and before
22 ~~November 5, 2008~~ January 16, 2009, teachers or other employees whose employment
23 terminates by application of law or contract or by action of a participating school
24 administrative unit before July 1, 2009 may not be transferred.

25 B. Teachers and other employees who are transferred to the regional school unit
26 prior to the completion of the applicable probationary period for their position have
27 the length of their probationary period calculated from the date of their most recent
28 date of employment by the participating school administrative unit.

29 **6. Collective bargaining.** The following provisions apply:

30 A. On July 1, 2008 for regional school units approved prior to January 16, 2008 and
31 on July 1, 2009 for regional school units approved after January 15, 2008 and before
32 ~~November 5, 2008~~ January 16, 2009, the regional school unit board of directors shall
33 assume all of the obligations, duties, liabilities and rights of the participating school
34 administrative units for all purposes under Title 26, chapter 9-A. The regional
35 school unit is considered a single employer. Notwithstanding any other provision of
36 law, the responsibilities of the regional school unit include:

37 (1) Continued recognition of all bargaining agents that represented any
38 bargaining units of employees who were employed by a participating school
39 administrative unit, pending completion of merger proceedings described in this
40 section;

41 (2) Assumption and continued observance of all collective bargaining
42 agreements between such bargaining agents and a participating school
43 administrative unit, which agreements continue in effect for the remainder of
44 their unexpired term unless the bargaining agent and regional school unit
45 mutually agree otherwise; and

- 1 (3) Collective bargaining for an initial or successor collective bargaining
2 agreement in any bargaining unit in which a collective bargaining agreement is
3 not in effect on the operational date and for any interim agreement that may be
4 required to align expiration dates in a regional school unit-wide bargaining unit,
5 as described in this subsection.
- 6 B. As early as possible but no later than August 31, 2011 for regional school units
7 approved prior to January 15, 2008 and no later than August 31, 2012 for regional
8 school units approved after January 15, 2008 and before ~~November 2, 2008~~ January
9 16, 2009, all bargaining units must be structured on a regional school unit-wide basis.
10 Bargaining units that existed in the participating school administrative units shall
11 merge in accordance with the procedures and criteria in this section. Merger into
12 regional school unit-wide bargaining units is not subject to approval or disapproval of
13 employees.
- 14 (1) Merger into regional school unit-wide bargaining units must be completed
15 according to the schedule contained in this subsection, and no later than the latest
16 expiration date of any collective bargaining agreement that was in effect on the
17 operational date, which covered any employees in the merged unit.
- 18 (2) There must be one unit of teachers and, to the extent they are currently
19 included in bargaining units, other certified professional employees, excluding
20 principals and other administrators.
- 21 (3) Any additional bargaining units in a regional school unit must be structured
22 as follows:
- 23 (a) In the initial establishment of such units, units must be structured
24 primarily on the basis of the existing pattern of organization, maintaining the
25 grouping of employee classifications into bargaining units that existed prior
26 to the creation of the regional school unit and avoiding conflicts among
27 different bargaining agents to the extent possible.
- 28 (b) In the event of a dispute regarding the classifications to be included
29 within a regional school unit-wide bargaining unit, the current bargaining
30 agent or agents or the regional school unit may petition the Maine Labor
31 Relations Board to determine the appropriate unit in accordance with this
32 section and Title 26, section 966, subsections 1 and 2.
- 33 (4) When there is the same bargaining agent in all bargaining units that will be
34 merged into a regional school unit-wide bargaining unit, the units must be
35 merged as of the operational date, and the regional school unit shall recognize the
36 bargaining agent as the representative of the merged unit.
- 37 (5) When all bargaining units that will be merged into a regional school unit-
38 wide bargaining unit are represented by separate local affiliates of the same state
39 labor organization, the units must be merged as of the operational date. The
40 identity of the single affiliate that will be designated the bargaining agent for the
41 merged unit must be selected by the existing bargaining agents and the state labor
42 organization. Upon completion of the merger and designation of the bargaining
43 agent and notification by the state organization to the regional school unit, the
44 regional school unit shall recognize the designated bargaining agent as the

- 1 representative of employees in the merged unit. If necessary, the parties will then
2 execute a written amendment to any collective bargaining agreement then in
3 effect to change the name of the bargaining agent to reflect the merger.
- 4 (6) Where there are bargaining units that will be merged into a regional school
5 unit-wide bargaining unit in which there are employees who are not represented
6 by any bargaining agent and other employees who are represented either by the
7 same bargaining agent or separate local affiliates of the same state labor
8 organization, the units must be merged as of the operational date as long as a
9 majority of employees who compose the merged unit were represented by the
10 bargaining agent prior to the merger. The procedures for merger of separate local
11 affiliates of the same state labor organization described in subparagraph (5) must
12 be followed if applicable. If prior to the merger a bargaining agent did not
13 represent a majority of employees who compose the merged unit, a bargaining
14 agent election must be conducted by the Maine Labor Relations Board pursuant
15 to subparagraph (8).
- 16 (7) When there are unexpired collective bargaining agreements with different
17 expiration dates in the merged bargaining units described in subparagraphs (4),
18 (5) and (6), all contracts must be honored to their expiration dates unless
19 mutually agreed to otherwise by the public employer and the bargaining agent.
20 Collective bargaining agreements must be bargained on an interim basis in any
21 merged bargaining unit so that all collective bargaining agreements expire on the
22 same date.
- 23 (8) When bargaining units with different bargaining agents must be merged into
24 a single regional school unit-wide bargaining unit pursuant to this subsection, the
25 bargaining agent of the merged bargaining unit must be selected in accordance
26 with Title 26, section 967, except as modified in this subparagraph.
- 27 (a) A petition for an election to determine the bargaining agent must be filed
28 with the Maine Labor Relations Board by any of the current bargaining
29 agents or the regional school unit.
- 30 (b) The petition must be filed not more than 90 days prior to the expiration
31 date of the agreement having the latest expiration date among the bargaining
32 units that will be merged into the regional school unit-wide bargaining unit.
- 33 (c) The election ballot may contain only the names of the bargaining agents
34 of bargaining units that will be merged into the regional school unit-wide
35 bargaining unit and the choice of "no representative," but no other choices.
36 No showing of interest is required from any such bargaining agent other than
37 its current status as representative.
- 38 (d) The obligation to bargain with existing bargaining agents continues from
39 the operational date until the determination of the bargaining agent of the
40 regional school unit-wide bargaining unit under this subsection; but in no
41 event may any collective bargaining agreement that is executed after the
42 operational date extend beyond the expiration date of the agreement having
43 the latest expiration date among the bargaining units that will be merged into
44 the regional school unit-wide bargaining unit that was in effect on the
45 operational date.

(e) The Maine Labor Relations Board shall expedite to the extent practicable all petitions for determination of the bargaining agent in the regional school unit-wide bargaining unit filed pursuant to this subsection.

(f) The bargaining units must be merged into a regional school unit-wide bargaining unit as of the date of certification of the results of the election by the Maine Labor Relations Board, or the expiration of the collective bargaining agreements in the unit, whichever occurs later.

C. After the merger of bargaining units into a regional school unit-wide bargaining unit, the bargaining agent of a regional school unit-wide bargaining unit and the regional school unit shall engage in collective bargaining for a collective bargaining agreement for the regional school unit-wide bargaining unit. In the collective bargaining agreement for each regional school unit-wide bargaining unit, the employment relations, policies, practices, salary schedules, hours and working conditions throughout the regional school unit must be made uniform and consistent as soon as practicable.

(1) In the event that the parties are unable to agree upon an initial regional school unit-wide collective bargaining agreement, they must use the dispute resolution procedures pursuant to Title 26, section 965 to resolve their differences.

7. Superintendent contracts. The contracts between the superintendents and school administrative units within the regional school unit are transferred to the regional school unit board of directors. The regional school unit board of directors shall determine the superintendents' duties within the regional school unit.

16-A. Local education unit. "Local education unit" means a state-approved unit of school governance responsible for operating or constructing public schools, but is not responsible for administration of public schools, that is a member of a regional school union. A local education unit is a school administrative unit for all purposes except the core functions identified in section 2001 and any additional functions delegated to the regional school union committee as authorized in section 2001.

32 **§2001. Regional school union**

33 **1. Formation.** A regional school union composed of school administrative units
34 may be formed pursuant to a reorganization plan. A municipal school unit, a school
35 administrative district, a community school district or any other municipal or quasi-
36 municipal corporation responsible for operating or constructing public schools, except a
37 career and technical education region, may be a local education unit within a regional
38 school union.

1 2. Laws governing local education units. Except as otherwise provided in this
2 chapter, a local education unit that is part of a regional school union is subject to the laws
3 set forth in this Title governing that local education unit, including but not limited to laws
4 governing budget format and budget adoption procedures.

5 3. Regional school union committee. The governing body of a regional school
6 union is the regional school union committee, which must be made up of representatives
7 from the school boards of member local education units and must be apportioned in
8 accordance with one-person, one-vote principles.

9 4. Core functions. The regional school union committee's core functions, which
10 may not be delegated to a local education unit except as provided in this subsection, are:

11 A. Employment and discharge of a superintendent pursuant to section 1001,
12 subsection 3 and chapter 101, subchapter 2;

13 B. Administration of accounting, payroll, financial management, purchasing
14 insurance and auditing;

15 C. Administration of special education duties of local education units under chapter
16 303;

17 D. Administration of transportation;

18 E. Adoption of a core curriculum, standardized testing and assessment aligned with
19 the system of learning results established in section 6209;

20 F. Preparation of the regional school union budget;

21 G. Reporting required by state or federal law, rule or regulation;

22 H. Functioning as the employer of all employees performing the core functions and
23 performance of any additional functions delegated to the regional school union;

24 I. The establishment of a common school calendar, except that local education units
25 may adopt local variations from the regional school union calendar;

26 J. Adoption of common policies for all schools in the regional school union pursuant
27 to section 1001, subsection 1-A, except that the local education units may adopt local
28 variations from the regional school union policies; and

29 K. Apportionment of costs of the regional school union among its local education
30 units in accordance with a cost-sharing formula established by its approved
31 reorganization plan and certification to the treasurer of each local education unit and
32 to the commissioner of the amounts to be paid.

33 5. Delegation of additional functions. A reorganization plan or the legislative
34 bodies of the local education units in a regional school union may delegate functions in
35 addition to those set out in subsection 4 to the regional school union committee.

36 6. Title to property. A reorganization plan may provide that title to real and
37 personal property in local education units may be either transferred to the regional school
38 union or retained by the local education unit, as long as the plan clearly allocates the
39 responsibilities for the management of school property under section 1001, subsection 2

1 between the regional school union committee and the school board of the local education
2 unit.

3 **§2002. Regional school union committee**

4 **1. Formation.** In accordance with an approved reorganization plan, the school
5 boards of the local education units composing a regional school union shall form a
6 regional school union committee. The school board of a local education unit in a regional
7 school union shall designate one or more of its members to serve on the regional school
8 union committee as provided in the reorganization plan.

9 **2. Term of office.** The term of office of regional school union committee members
10 must be determined by the approved reorganization plan.

11 **3. Compensation.** Compensation for attendance at a regional school union
12 committee meeting must be between \$10 and \$25 per meeting for each member.
13 Whenever the committee members recommend increasing their compensation, they shall
14 submit their recommendation to the voters in the regional school union for approval.

15 **A.** On notification by the regional school union committee, the municipal officers
16 shall, at the next regular or special town meeting or city election, prepare a warrant or
17 ballot for the purpose of voting on the proposed increase. The question must be in the
18 following form.

19 "Do you favor paying a member of the regional school union committee
20 compensation at the rate of \$..... for each meeting that member attends?"

21 **B.** An increase in compensation is not effective unless approved by a majority of the
22 voters voting on the question set out in paragraph A.

23 **4. Secretary and treasurer.** The superintendent serves as secretary and treasurer of
24 the regional school union committee and shall give a bond to the regional school union
25 committee of a sum and with the sureties as the regional school union determines. The
26 bond must be deposited with the chair of the regional school union committee. The
27 expense of that bond must be paid by the regional school union. The bond premium,
28 compensation paid committee members for attendance at meetings and expenses of the
29 regional school union must be paid from funds of the regional school union by the
30 treasurer on vouchers presented and certified by the superintendent and approved by a
31 majority of the regional school union committee or a finance committee duly elected
32 annually by that committee. Notwithstanding section 1055, a superintendent of a regional
33 school union may designate another person with State of Maine administrative
34 certification to perform the duties of secretary of the school board of a local education
35 unit.

36 **5. Oath of office.** Before a newly elected member's first regional school union
37 committee meeting, that member must take the following oath or affirmation before a
38 dedimus justice or notary public.

39 "I do swear that I will faithfully discharge to the best of my abilities the
40 duties incumbent on me as a regional school union committee member of (name of
41 regional school union) according to the Constitution of Maine and laws of this State, so
42 help me God."

R.G.S.

1 A. A member shall take the oath or affirmation and return a certificate documenting
2 that the oath or affirmation has been taken to the secretary of the regional school
3 union committee to place in the regional school union committee records.

4 B. If a member is conscientiously scrupulous of taking an oath, the word "affirm"
5 may be used instead of "swear" and the words "this I do under the pains and penalty
6 of perjury" may be used instead of the words "so help me God."

7 6. Election of officers. The regional school union committee shall elect a chair and
8 vice-chair and other officers as may be necessary.

9 **§2003. Methods of apportionment**

10 1. Method B: weighted votes. Under the method of representation referred to as
11 "Method B," members cast weighted votes.

12 A. The reapportionment committee under section 2024 shall apportion 1,000 votes
13 among all the members of the committee. The ratio of the number of votes cast by the
14 members representing a school administrative unit or municipality in relation to the
15 number 1,000 must be the same ratio to the nearest whole number as the population
16 of the school administrative unit or municipality is in relation to the population of all
17 the school administrative units and municipalities in the regional school union, as
18 determined by the latest Federal Decennial Census or Federal Estimated Census.

19 B. To ensure the use of whole numbers, the 1,000 votes apportioned among the
20 committee members may not be increased or decreased by more than 5 votes.

21 C. A plan may not permit the voting power of any member to exceed by more than
22 5% the percentage of voting power the member would have if all 1,000 votes were
23 apportioned equally among the members.

24 D. For a local education unit represented by 2 or more members, the votes cast by
25 them must be divided equally among them.

26 2. Method D: other. Under the method of representation referred to as "Method D,"
27 members are selected by any method other than that set forth in subsection 1 that meets
28 the requirements of the one-person, one-vote principle.

29 **§2004. Appropriation for regional school union expenses**

30 Local education units shall appropriate for regional school union expenses their share
31 of the costs of the regional school union in accordance with a cost-sharing formula
32 established by its approved reorganization plan. The proportion to be paid by a local
33 education unit must be paid out of the appropriation made for the support or maintenance
34 of public schools.

35 **§2005. Rules**

36 The state board may adopt rules to carry out this chapter. Rules adopted under this
37 section are routine technical rules as defined in Title 5, chapter 375, subchapter 2-A.

FORMATION OF REGIONAL SCHOOL UNION

§2011. Formation of a regional school union; reorganization planning and approval

The residents of 2 or more school administrative units may form a regional school union that is a body politic and corporate pursuant to this section.

1. Notice of intent. Each school administrative unit shall file with the commissioner a notice of intent to engage in planning and negotiations with other school administrative units for the purpose of developing a reorganization plan to form a regional school union under this chapter. The commissioner shall respond to each notice of intent providing information regarding the process and whether the intended action complies with the requirements of this chapter.

2. Reorganization planning committee. The school administrative units that intend to engage in planning and negotiation to create a regional school union shall form a reorganization planning committee.

A. For each proposed regional school union, the commissioner shall provide guidelines for the formation of a reorganization planning committee including representation from the school administrative units included in the notice of intent, member municipalities and members of the general public who are residents of the proposed regional school union. The guidelines must include roles and responsibilities of the committee, timelines for submission of the plan, the format for reporting the reorganization plan and evaluation criteria for approval of the plan.

B. Reorganization planning committees shall hold one or more public meetings to gather input from community members and to determine the sentiment of the public.

3. Submission of plans. Each school administrative unit shall submit to the commissioner its proposed reorganization plan for consolidation into a regional school union that meets the requirements of paragraphs A and B.

A. A reorganization plan must include:

- (1) The local education units to be included in the proposed reorganized regional school union;
- (2) The size, composition and apportionment of the governing body;
- (3) The method of voting of the governing body;
- (4) The powers and duties of the regional school union;
- (5) The disposition of real and personal school property;
- (6) The disposition of existing school indebtedness and lease-purchase obligations;
- (7) The assignment of school personnel contracts, school collective bargaining agreements and other school contractual obligations;

- 1 (8) The disposition of existing school funds and existing financial obligations,
2 including undesignated fund balances, trust funds, reserve funds and other funds
3 appropriated for school purposes;
- 4 (9) A transition plan that addresses the development of a budget for the first
5 school year of the regional school union and interim personnel policies;
- 6 (10) Documentation of the public meeting or public meetings held to prepare or
7 review the reorganization plan;
- 8 (11) An explanation of how units that approve the reorganization plan will
9 proceed if one or more of the proposed members of the regional school union fail

- 11 (12) An estimate of the cost savings to be achieved by the formation of a
12 regional school union and how these savings will be achieved;
- 13 (13) A method of sharing regional school union costs among its member local
14 education units and a process of amending the cost-sharing formula; and
- 15 (14) Such other matters as the governing bodies of the school administrative
16 units in existence on the effective date of this chapter may determine to be

5. Results of referendum. A school administrative unit shall report the results of the referendum to the department following the referendum election.

A. For a referendum conducted pursuant to subsection 3:

(1) A reorganization plan is approved by a kindergarten to grade 12 school administrative district or kindergarten to grade 12 community school district if the majority of votes cast in the district is in favor of approval of the plan;

6. Amended certificate of organization. If a plan for reorganization has been approved by the commissioner and approved by voters at the referendum under subsections 3 and 4, the state board shall issue an amended certificate of organization to the reorganized regional school union.

SUBCHAPTER 3

REGIONAL SCHOOL UNION GOVERNANCE

§2021. Powers and duties

The regional school union committee:

1. Regional school union name. May select an unofficial name for the regional school union;

2. Finance committee. May elect a finance committee of 3 or more members, who must be regional school union committee members;

3. Bylaws. Shall adopt bylaws for the regulation of the affairs of the regional school union committee and the conduct of its business; and

1 4. Gifts. May accept and receive money or other property, outright or in trust, for
2 any specified benevolent or educational purpose. The regional school union committee
3 shall comply with this subsection in accepting gifts.

4 A. If the regional school union committee receives written notice from a prospective
5 donor or a representative of the donor of a proposed gift, the regional school union
6 committee shall submit the matter to its next regular meeting or shall call a special
7 meeting and shall, within 10 days after the meeting, send written notice to the
8 prospective donor or representative of its acceptance or rejection.

9 B. If the gift is in trust, the regional school union committee shall cause the trust
10 funds to be deposited or invested according to Title 30-A, chapter 223, subchapter
11 3-A.

12 (1) Unless prohibited by a trust instrument, the regional school union may treat
13 any 2 or more trust funds as a single fund for the purposes of investment.

14 (2) After deduction for management expenses, any interest earned or capital
15 gains realized must be prorated among the various trust funds.

16 (3) Property or securities included in the corpus of a trust fund must be retained
17 where the trust instrument so provides.

18 (4) Unless otherwise specified in the trust instrument, only the annual income
19 from the trust fund may be spent.

20 (5) If the regional school union fails to comply with the terms of the trust
21 instrument, the trust fund is subject to reversion to the donor or the donor's heirs.

22 C. If the money or other property is a conditional gift for any specified benevolent or
23 educational purpose, this paragraph applies.

24 (1) When the donor's part of the agreement respecting the execution of the
25 conditional gift has been completed, the regional school union shall perpetually
26 comply with, and may raise money to carry into effect, the conditions upon
27 which it was made.

28 (2) Unless otherwise specified by its terms, a conditional gift of money must be
29 deposited or invested according to Title 30-A, chapter 223, subchapter 3-A.

30 **§2022. Quorum**

31 A majority of the regional school union committee in number and voting power
32 constitutes a quorum.

33 **§2023. Regional school union committee vacancies**

34 **1. Definition of vacancy.** A vacancy on a regional school union committee occurs:

35 A. When the term of office of a regional school union committee member expires;

36 B. When a regional school union committee member changes residency from the
37 local education unit represented. Evidence that an individual is registered to vote in a

1 municipality in a local education unit is prima facie evidence of that individual's

3 C. On the death of a regional school union committee member; or

4 D. When a regional school union committee member resigns from the regional

17 **§2024. Reapportionment**

18 The commissioner shall determine the necessity for reapportionment.

19 1. Duties of commissioner. The commissioner shall determine if a regional school
20 union is apportioned in accordance with the one-person, one-vote principle if:

21 A. The commissioner receives a request by the regional school union committee; or

22 B. The commissioner receives a petition signed by a number of regional school
23 union voters equal to at least 10% of the voters in the regional school union who
24 voted in the last gubernatorial election.

25 In addition to a determination initiated by a request pursuant to paragraph A or a petition
26 pursuant to paragraph B, the commissioner may, of the commissioner's own accord,
27 determine that a regional school union is not apportioned according to the one-person,
28 one-vote principle.

29 The commissioner shall make a determination under paragraph A or B within 30 days of
30 receiving the request or the petition.

31 2. Awaiting census results. If the commissioner receives a request within 12
32 months before a Federal Decennial Census or Federal Estimated Census, the
33 commissioner may wait until after the new census figures are available to make a
34 determination under subsection 1.

35 3. Findings and order. If the commissioner finds the regional school union
36 representation is not apportioned in accordance with the one-person, one-vote principle,
37 the commissioner, within 7 days of that decision, shall notify the superintendent of the
38 regional school union of the finding and order the superintendent to notify the school
39 board in each local education unit in the regional school union and the regional school
40 union committee to create a reapportionment committee. The superintendent's notification
41 must include the commissioner's notification, the information provided pursuant to

1 subsection 6 and the time and place for the first meeting of the committee, which must be

3 **4. Reapportionment committee membership.** The reapportionment committee
4 consists of 2 members from each school board, chosen by the respective school boards.

5 **5. Quorum.** A majority of the reapportionment committee constitutes a quorum.

6 **6. Duties of commissioner.** The commissioner shall provide the superintendent of
7 the regional school union with the most recent Federal Decennial Census or Federal
8 Estimated Census figures for each local education unit in the regional school union and at
9 least one recommended apportionment plan.

10 **7. Duties of the reapportionment committee.** The reapportionment committee
11 shall:

12 A. Elect a chair and secretary and may adopt suitable rules of procedure;

13 B. Consider and by majority vote adopt a reapportionment plan including the method
14 of representation, total number of members and number of members representing
15 each local education unit; and

16 C. Within 90 days of the first meeting, send a report of its reapportionment plan to
17 the state board for approval. It may, within the 90-day limit, submit alternative plans
18 for apportionment.

19 **8. Commissioner approval.** The commissioner shall approve or disapprove the
20 reapportionment committee plan under subsection 7 within 30 days of receiving it.

21 **9. Failure to gain commissioner approval.** If a reapportionment plan has not been
22 adopted by the reapportionment committee or approved by the commissioner within the
23 time limits of subsection 7, the commissioner shall prepare a suitable plan.

24 **10. Putting the approved plan into effect.** On approval of a reapportionment plan,
25 the commissioner shall send a certified copy to the local education units and regional
26 school union committee. The original reapportionment plan must be retained in the
27 department files.

28 A. The reapportionment plan takes effect immediately upon approval. The
29 reapportionment committee shall determine the terms of the members to be elected at
30 the next annual municipal elections so as to comply with this chapter.

31 B. If the approved reapportionment plan requires a reduction of the number of
32 members to be elected in a municipality, the reduction must be achieved in
33 accordance with this paragraph.

34 (1) If possible, the reduction must be achieved by the voluntary resignation of

15 **SUBCHAPTER 4**

16 **CONTRACTS**

17 **§2031. Bid procedure**

18 1. Written bids. Bids must be in writing, sealed with the outside envelope or
19 wrapper plainly marked "Bid, not to be opened until (appropriate date)" and mailed to or
20 filed with the superintendent.

21 2. Time of opening. A member of the regional school union committee or an
22 employee of the regional school union may not open a bid until the appointed time.

23 3. Public opening. At the time and place stated in the public notice, and open to the
24 public, all bids must be opened by the superintendent or, in the superintendent's absence
25 or disability, by any member of the regional school union committee designated for the
26 purpose by the chair of the regional school union committee.

27 4. Reading. If any citizens who are not members of the regional school union
28 committee or employees of the regional school union are present or if any representatives
29 of the press are present, bids must at the time of opening either be made available for
30 examination by them or must be read aloud in a manner to be heard plainly by those in
31 attendance.

32 **§2032. Void contracts**

33 A contract made by the regional school union committee during the term of a
34 member who is pecuniarily interested in that contract, either directly or indirectly, is void,
35 unless the regional school union committee has advertised for sealed bids for that contract
36 and that advertisement for sealed bids has been published at least 5 days prior to the date
37 set for closing of bids in a newspaper having general circulation within the regional
38 school union.

39 **Sec. C-10. Reorganization planning.** A regional school union, as established in
40 the Maine Revised Statutes, Title 20-A, chapter 108, is deemed a regional school unit

1 under Public Law 2007, chapter 240, Part XXXX, section 36 for all purposes including
2 the goal for the number of regional units and the requirements with respect to the number
3 of students in each regional unit. The Commissioner of Education shall apply the same
4 criteria and shall allow the same exceptions for regional school unions as are applied to
5 regional school units. A reorganization plan for a regional school union is also subject to
6 the requirements of Public Law 2007, chapter 240, Part XXXX, section 36, subsection 6,
7 paragraph F that the reorganization plan address how administrative functions, duties and
8 noninstructional personnel will be reorganized so that the projected expenditures for
9 system administration, transportation, special education and facilities and maintenance
10 will not have an adverse impact on the instructional program. A reorganization plan for a
11 regional school union is subject to the same approval and referendum requirements as
12 provided in Public Law 2007, chapter 240, Part XXXX, section 36, subsections 8 and 9.

13 **Sec. C-11. Application.** Notwithstanding any provision of law to the contrary,
14 this Part applies to school administrative units and reorganization planning committees
15 that, on the effective date of this Part, are engaged in or are required to be engaged in
16 school reorganization planning pursuant to Public Law 2007, chapter 240, Part XXXX.'

SUMMARY

20 Under the existing law governing the reorganization of school administrative units, a
21 referendum must be held on a proposed reorganization by November 4, 2008.

22 Part B of this amendment changes the deadline by which a referendum must be held
23 to January 15, 2009 and changes dates that are linked to the referendum date by the same
24 amount of time.

25 Part C of this amendment authorizes regional school unions as an alternative to the
26 regional school unit method of school reorganization. A regional school union must
27 perform certain core functions, which include employment of a superintendent,
28 performance of all business functions, special education administration, transportation
29 administration, adoption of a core curriculum and all state and federal reporting. A
30 regional school union is formed in the same manner as a regional school unit by means of
31 a reorganization plan prepared by a reorganization planning committee, with approval of
32 the Commissioner of Education and approval at a referendum. Regional school unions
33 are subject to the same requirements as regional school units with respect to minimum

Fiscal Detail and Notes

Providing school administrative units with the option of forming a regional school union that allows for the dispersion of decision making authority to local education units within the regional school union except for certain core functions may increase the total cost of K-12 public education in future biennia due to less savings being achieved versus what was anticipated in Public Law 2007, chapter 240, Part XXXX. The amount can not be determined at this time and will depend on the number of regional school unions established and the ability of regional school unions and local education units within the regional school union to implement efficiencies. Two areas which could impact future General Fund costs include special education and transportation.

Title 20-A, §15681-A, sub-§2(D) requires that school administrative units receive sufficient funds for special education to ensure that the SAU's meet the federal maintenance of effort requirement for receiving federal Individuals with Disabilities Act funds. The maintenance of effort requirement states that the total amount of state and local funds budgeted by the local education agency for expenditures in a current fiscal year for the education of children with disabilities must be at least equal to the total amount of state and local school funds actually expended for the education of children with disabilities in the most recent preceding fiscal year. Less savings being achieved versus what was anticipated in Public Law 2007, chapter 240, Part XXXX may require a higher level of state and local funding in order to fulfill the maintenance of effort requirement.

Title 20-A, §15681-A, sub-§3 requires that school administrative units receive no less than 90% of the most recent year's reported net transportation expenditures. Less savings being achieved versus what was anticipated in Public Law 2007, chapter 240, Part XXXX may require a higher level of funding in order to meet the statutory requirement.
