COMMITTEE OF CONFERENCE AMENDMENT "A" to S.P. 741, L.D. 1932,  
Bill, "An Act To Amend the Laws Regarding School Funding"

Amend the bill by striking out everything after the enacting clause and before the  
emergency clause and inserting the following:

PART A

Sec. A-1. 20-A MRSA §1305-C, as enacted by PL 2007, c. 240, Pt. XXXX, §11,  
is amended to read:

§1305-C. Mandatory budget validation and cost center summary budget form

Notwithstanding any other law, school administrative district budgets developed after  
January 1, 2008 must conform to the format and referendum procedures for regional  
school units as set forth in sections ~~1305-A~~ and ~~1305-B~~ 1485 and 1486. A school  
administrative district is deemed to be a regional school unit solely for the purpose of  
developing a budget pursuant to sections 1485 and 1486.

Sec. A-2. 20-A MRSA §1452, as enacted by PL 2007, c. 240, Pt. XXXX, §13, is  
amended to read:

§1452. Application of general law; core functions of a regional school unit

Notwithstanding any provision of law to the contrary, schools operated by the  
regional school units established in accordance with this chapter are the official schools  
of the participating municipalities. The provisions of general law relating to public  
education apply to these schools. State funds for public schools must be paid directly to  
the treasurer of a regional school unit. The core functions for which a regional school unit  
is responsible include without limitation:

1. Employment of superintendent. Employment and discharge of a superintendent  
pursuant to section 1001, subsection 3 and chapter 101, subchapter 2;

2. Performance of business functions. Administration of accounting, payroll,  
financial management, purchasing insurance and auditing;

1 3. Special education administration. Administration of special education duties of  
2 school administrative units under chapter 303;

3 4. Transportation. Administration of transportation;

4 5. Core curriculum. Adoption of a core curriculum, standardized testing and  
5 assessments aligned with the system of learning results established in section 6209;

6 6. Budget. Adoption of the regional school unit budget;

7 7. Reporting. Reporting required by state or federal law or regulation;

8 8. Employment. Functioning as the employer of all employees working within the  
9 regional school unit for collective bargaining purposes and for all other purposes,  
10 including but not limited to those contained in section 1464, in Title 26, chapter 9-A and  
11 in all state and federal laws regulating the rights and duties of employers and employees;

12 9. School calendar. Establishment of a common school calendar, subject to local  
13 variations permitted by the regional school unit board; and

14 10. Adoption of policies. Adoption of policies for all schools in the regional school  
15 unit pursuant to section 1001, subsection 1-A, except that the local school committee may  
16 adopt policies not in conflict with the regional school unit policies.

17 **Sec. A-3. 20-A MRSA §1461, sub-§3, ¶B**, as enacted by PL 2007, c. 240, Pt.  
18 XXXX, §13, is amended to read:

19 B. In order for the plan to be approved by the commissioner, the governing bodies of  
20 school administrative units shall work within the following parameters.

21 (1) The proposed regional school unit must serve not fewer than 2,500 students,  
22 except where circumstances relating to the following factors justify an exception:

23 (a) Geography, including physical proximity and the size of the current  
24 school administrative unit;

25 (b) Demographics, including student enrollment trends and the composition  
26 and nature of communities in the regional school unit;

27 (c) Economics, including existing collaborations to be preserved or enhanced  
28 and opportunities to deliver commodities and services to be maximized;

29 (d) Transportation;

30 (e) Population density; or

31 (f) Other unique circumstances including the need to preserve existing or  
32 developing relationships, meet the needs of students, maximize educational  
33 opportunities for students and ensure equitable access to rigorous programs  
34 for all students.

35 When circumstances justify an exception to the size requirement of 2,500  
36 students, the unit must serve as close to 2,500 students as possible and in no case,  
37 except for coastal islands and schools operated by tribal school committees, may  
38 it serve fewer than 1,200 students.

1        In addition to the exceptions provided in this subparagraph to the requirement  
2        that a unit serve at least 1,200 students, the commissioner must lower the 1,200-  
3        student requirement in previous education units in which the commissioner finds  
4        that a population density of less than 50 residents per square mile makes a 1,200-  
5        student unit impractical.

6        (2) The plan must provide comprehensive programming for all students from  
7        kindergarten to grade 12 and must include at least one publicly supported  
8        secondary school.

9        (3) The plan must be consistent with the policies set forth in section 1451.

10       (4) The plan may not displace teachers or students or close any schools existing  
11       and operating during the school year immediately preceding reorganization,  
12       except as permitted under section 1512.

13       **Sec. A-4. 20-A MRSA §1461-A** is enacted to read:

14       **§1461-A. Transitional powers and duties of initial regional school unit board**

15       As used in this section, unless the context indicates otherwise, "regional school unit  
16       board" means the initial regional school unit board elected pursuant to section 1472-A.  
17       From the time of election of the regional school unit board to July 1st of the regional  
18       school unit's first operational year, the regional school unit board shall establish interim  
19       rules of procedures and shall elect officers who shall serve until officers are elected at a  
20       meeting following the operational date of the regional school unit. The regional school  
21       unit board's powers and duties during this period are governed by this section.

22       **1. Selection of superintendent.** The regional school unit board shall select a  
23       superintendent for the regional school unit in accordance with section 1051 to carry out  
24       the duties specified in section 1055. During the interim period, the salary, office and other  
25       expenses of the superintendent, as well as the costs of the regional school unit board,  
26       including insurance, must be allocated to the school administrative units by the cost-  
27       sharing formula established in accordance with section 1481-A and included in the  
28       reorganization plan for the regional school unit.

29       **2. Budget preparation and approval.** The regional school unit board shall prepare  
30       the annual budget for the first operational year of the regional school unit in time for its  
31       presentation to and consideration by the regional school unit board in accordance with  
32       subchapter 4. Specific duties may be assigned to existing personnel with the approval of  
33       the employing school administrative unit. The regional school unit board shall complete  
34       the budget development process and recommend a budget for consideration by the  
35       legislative body responsible for final budget approval and the residents of the regional  
36       school unit. The budget format, approval procedures and assessments for the regional  
37       school unit's first operational year budget must be in accordance with this chapter.

38       **3. Authorization.** The regional school unit board is authorized to take all other  
39       actions provided under state law to prepare the regional school unit to become operational  
40       on July 1st for the first operational year, including the authority to open and maintain  
41       accounts, to incur expenses to be allocated among the regional school unit's member  
42       school administrative units in accordance with the reorganization plan for the regional

1 school unit and to file applications for school construction projects and revolving  
2 renovation fund loans and other available funding.

3 4. Fiscal agent. The regional school unit board is authorized to expend start-up  
4 funds for the regional school unit. A school administrative unit within the regional  
5 school unit may serve as a fiscal agent and may expend any start-up funds on behalf of  
6 the new regional school unit prior to the regional school unit's operational date without  
7 calling for a special meeting of the local legislative body.

8 **Sec. A-5. 20-A MRSA §1472, sub-§2, ¶C**, as enacted by PL 2007, c. 240, Pt.  
9 XXXX, §13, is amended to read:

10 C. A plan may not permit the voting power of any director to exceed by more than  
11 2% 5% the percentage of voting power the director would have if all 1,000 votes  
12 were apportioned equally among the directors.

13 **Sec. A-6. 20-A MRSA §1472-A** is enacted to read:

14 **§1472-A. Election of initial regional school unit board**

15 1. Election; interim secretary; duties. Within 30 days of the issuance of a  
16 certificate of organization for the regional school unit by the state board pursuant to  
17 section 1461, subsection 7, the members of the school boards of the school administrative  
18 units within the regional school unit shall conduct a joint meeting for the purposes of  
19 electing an interim secretary of the regional school unit and determining a date for the  
20 election of the initial regional school unit board. The interim secretary shall notify the  
21 municipal officers of the member municipalities of the regional school unit of the date of  
22 the election. The election must be conducted in accordance with section 1473, subsection  
23 2, except that the election duties of the secretary and the regional school unit board must  
24 be performed by the interim secretary. The duties of the interim secretary include:

25 A. Notifying the municipal officers of the date of the election;

26 B. Furnishing nomination papers at least 10 days before the deadline for filing  
27 nomination papers;

28 C. Receiving completed nomination papers in accordance with section 1473,  
29 subsection 2;

30 D. Preparing and distributing election ballots in accordance with section 1473,  
31 subsection 2;

32 E. Receiving the town clerk's certification of the results of the voting in each  
33 member municipality;

34 F. Tabulating the town clerk's certification of the results of the voting in each  
35 member municipality;

36 G. Accepting any recount petitions that may have been filed pursuant to section  
37 1473, subsection 2, paragraph C; and

38 H. Totaling the votes cast for each candidate and notifying the clerk in each  
39 municipality, the candidates and the commissioner of the final results of the voting  
40 and the names and addresses of the persons elected as directors.

1 **2. Initial meeting.** In accordance with section 1473, subsection 1, the clerk of each  
2 municipality within the regional school unit shall forward the names and addresses of the  
3 directors elected to represent that municipality to the state board with other data regarding  
4 their election as the state board may require. On receipt of the names and addresses of all  
5 of the directors, the state board shall set a time, place and date for the first meeting of the  
6 directors and give notice to the directors in writing, sent by registered or certified mail,  
7 return receipt requested, to the addresses provided by the municipalities.

8 **Sec. A-7. 20-A MRSA §1472-B** is enacted to read:

9 **§1472-B. Staggered initial terms**

10 Notwithstanding section 1471, subsection 2, the initial directors elected to a regional  
11 school unit board shall meet and draw lots for their term lengths as specified in this  
12 section.

13 **1. Municipalities with annual elections.** In municipalities with annual elections,  
14 1/3 of the directors serve one-year terms, 1/3 of the directors serve 2-year terms and 1/3  
15 of the directors serve 3-year terms. If the number of directors is not evenly divisible by 3,  
16 the first remaining director serves a 3-year term and the 2nd remaining director serves a  
17 2-year term.

18 **2. Municipalities with biennial elections.** In municipalities with biennial elections,  
19 half of the directors serve 4-year terms and half of the directors serve 2-year terms. If the  
20 number of directors is not divisible by 2, the remaining director serves a 4-year term.

21 The directors shall serve their terms as determined under this section and any  
22 additional period until the next regular election of the municipalities. Thereafter, the  
23 directors' terms of office are as established in section 1471.

24 **Sec. A-8. 20-A MRSA §1478,** as enacted by PL 2007, c. 240, Pt. XXXX, §13, is  
25 repealed and the following enacted in its place:

26 **§1478. Local school committees**

27 **1. Formation.** A reorganization plan under section 1461 or a regional school unit  
28 board may authorize the formation of a local school committee for a member  
29 municipality established in accordance with chapter 111, subchapter 1.

30 **2. Delegation of functions.** A reorganization plan that has been approved in  
31 accordance with subchapter 2 or a regional school unit board may delegate a local school  
32 committee to perform any duties, functions and services other than those reserved to the  
33 regional school unit under subchapter 1. The core functions provided by a regional  
34 school unit pursuant to section 1452 may be supplemented at the expense of any member  
35 municipality.

36 **3. Budget responsibility.** A reorganization plan that has been approved in  
37 accordance with subchapter 2 or a regional school unit board may authorize a local school  
38 committee to present to the board a proposed budget for the local school in a form that is  
39 consistent with section 1485. The proposed local school budget must be submitted in  
40 time to be included in the budget for the regional school unit. Proposed expenditures that  
41 are not included in the regional school unit budget may be separately appropriated by the  
42 municipality to be expended by the regional school unit in accordance with the

1 appropriation. Supplemental municipal appropriations for education are not subject to  
2 section 1486.

3 4. Title to property. School property overseen by a local school committee may be  
4 owned either by the municipality or by the regional school unit as long as there is a clear  
5 allocation of responsibilities for management of all of the school property in the regional  
6 school unit.

7 **Sec. A-9. 20-A MRSA §1481**, as enacted by PL 2007, c. 240, Pt. XXXX, §13, is  
8 repealed.

9 **Sec. A-10. 20-A MRSA §1481-A** is enacted to read:

10 **§1481-A. Finances**

11 **1. Apportionment of costs for regional school unit.** A regional school unit may  
12 raise money, in addition to the local contribution pursuant to section 15690, subsection 1,  
13 for establishing and maintaining public schools, erecting buildings and providing  
14 equipment for educational purposes. The additional costs of operating a regional school  
15 unit must be shared among all municipalities within the regional school unit by the same  
16 local share percentages for each municipality resulting from the determination of the local  
17 contribution under section 15688.

18 **2. Existing cost-sharing agreement.** Notwithstanding subsection 1, a cost-sharing  
19 agreement in existence on June 7, 2007 that was adopted pursuant to Public Law 2005,  
20 chapter 2 or pursuant to a private and special law remains in existence unless the parties  
21 to the agreement modify or terminate the agreement:

22 A. As part of a reorganization to regional school units under this chapter; or

23 B. As a result of a negotiated agreement between the parties to the cost-sharing  
24 agreement.

25 **3. Method included in reorganization plan.** Notwithstanding subsection 1, a  
26 regional school unit may use a method of cost sharing that was included in a  
27 reorganization plan developed pursuant to section 1461 or Public Law 2007, chapter 240,  
28 Part XXXX, section 36 as long as the method complies with this subsection.

29 A. The costs of operating a regional school unit must be shared among all  
30 municipalities within the unit in one of the following ways.

31 (1) Under a property valuation method, municipalities in a unit shall share costs  
32 in the same proportion as each municipality's property fiscal capacity as defined  
33 in section 15672, subsection 23 is to the unit's property fiscal capacity.

34 (2) Under an alternate method of cost sharing, municipalities in a unit shall share  
35 costs based on:

36 (a) The number of resident pupils in each town;

37 (b) The property fiscal capacity of each member municipality as defined in  
38 section 15672, subsection 23;

39 (c) Any combination of divisions (a) and (b); or

1           (d) Any other factor or combination of factors that may, but need not,  
2           include divisions (a) or (b).

3           B. A process of amending the cost-sharing formula must be included in the  
4           reorganization plan.

5           Notwithstanding any provision of law to the contrary, a cost-sharing agreement in  
6           existence on June 7, 2007 that was adopted pursuant to Public Law 2005, chapter 2 or  
7           pursuant to a private and special law may not be construed to preempt the formation of a  
8           regional school unit under this chapter. Notwithstanding any provision of law to the  
9           contrary, a cost-sharing agreement between 2 or more municipalities in existence on June  
10           7, 2007 that was adopted prior to June 7, 2007 may not be construed to preempt the  
11           formation of a regional school unit under this chapter.

12           Notwithstanding any provisions of law to the contrary, a municipality within a  
13           regional school unit may raise money and direct the spending of the funds to any school  
14           within the regional school unit.

15           **Sec. A-11. 20-A MRSA §1482-A** is enacted to read:

16           **§1482-A. Budget meeting**

17           A regional school unit board shall hold a regional school unit budget meeting at a  
18           time it determines.

19           **1. Warrant.** The budget meeting must be called by a warrant. The warrant must:

20           A. Be signed by a majority of the regional school unit board;

21           B. Specify the time and place of the meeting;

22           C. Include the proposed school budget and other articles the regional school unit  
23           board chooses to place before the voters, excluding authorization to borrow money  
24           for school construction purposes;

25           D. Specify the state and local shares of the state-local allocation and local leeway  
26           and additional expenditures without state participation; and

27           E. Be directed to a resident of the regional school unit by name ordering the resident  
28           to notify all voters within the regional school unit to assemble at the time and place  
29           appointed.

30           **2. Notice.** An attested copy of the warrant must be posted by the person to whom it  
31           is directed in some conspicuous public place in each of the municipalities within the  
32           regional school unit at least 7 days before the meeting. The person who gives notice of  
33           the meeting shall make a return of the posting on the warrant stating the manner of notice  
34           in each municipality and the time when it was given.

35           **3. Requested articles.** If requested by a written petition of at least 10% of the  
36           number of voters voting for the gubernatorial candidates in the last gubernatorial election  
37           in each municipality within the regional school unit, the regional school unit board shall  
38           place specific articles, not in conflict with existing state statutes, in the warrants for  
39           consideration at the next annual regional school unit budget meeting. To be included in  
40           the warrant, a petition must be received by the regional school unit board at least 15 days

1 before the date set for the budget meeting. When placed on the warrant, the articles must  
2 be considered before action relating to the appropriation of money for the operation of  
3 schools may be taken.

4 **Sec. A-12. 20-A MRSA §1482-B** is enacted to read:

5 **§1482-B. Annual budget meeting procedures**

6 The following procedures must be used at a regional school unit annual budget  
7 meeting.

8 **1. Election of moderator.** The secretary of the regional school unit board or the  
9 chair of the regional school unit board when the secretary is absent shall open the annual  
10 budget meeting and call for the election of a moderator, receive and count votes for the  
11 moderator and swear in the moderator.

12 **2. Appointing ballot clerks.** The moderator shall appoint from the certified voting  
13 list the ballot clerks necessary for the efficient operation of the annual budget meeting.  
14 The moderator shall swear in the clerks.

15 **3. Budget consideration.** The superintendent of the regional school unit shall  
16 thoroughly explain the budget. The voters must have an opportunity to be heard. The  
17 voters may change only items dealing with:

- 18 A. The expenses necessary to operate the regional school unit;
- 19 B. Appropriations for the reserve fund; and
- 20 C. Appropriations for the contingency fund and school construction purposes.

21 **4. Approval.** A majority vote of those voters present and voting is necessary for the  
22 approval of the annual budget.

23 **5. Voting lists.** Registration of voters for the annual budget meeting must be held in  
24 each member municipality in accordance with Title 21-A, section 122.

25 A. Prior to the annual budget meeting, the municipal clerks of the member  
26 municipalities shall supply to the regional school unit board certified corrected copies  
27 of the registered voters of their municipalities.

28 B. The certified corrected copies under paragraph A must be used in determining the  
29 voters who are eligible to vote at the annual budget meeting.

30 **6. Written ballot.** An article must be voted on by written ballot if at least 10% of  
31 those present and voting vote to use a written ballot. The department, in consultation  
32 with municipal and school officials and with organizations representing those officials,  
33 shall develop and distribute guidelines to assist regional school unit annual budget  
34 meeting moderators in explaining and implementing this subsection.

35 **Sec. A-13. 20-A MRSA §1506, sub-§1, ¶A**, as enacted by PL 2007, c. 240, Pt.  
36 XXXX, §13, is amended to read:

37 A. "Existing debt" means any bond, note, loan agreement, lease-purchase agreement  
38 or other debt instrument issued prior to July 1, ~~2008~~ 1st of the first operational year of  
39 the new unit for the purposes of funding public schools, or for refinancing such debt,

3 **Sec. A-14. 20-A MRSA §1506, sub-§4**, as enacted by PL 2007, c. 240, Pt.  
4 XXXX, §13, is amended to read:

5 **4. Debt of original education units.** After July 1, ~~2008~~, 1st of the first operational  
6 year of the new unit for each original education unit with existing debt that has  
7 reorganized into a new unit, if the new unit has not agreed to assume liability to pay that  
8 existing debt, the regional school unit board shall serve as agent for purposes of that  
9 existing debt and has full authority to:

10 A. Sue and be sued in the name of the original education unit with respect to the  
11 existing debt;

12 B. Determine the debt service due each fiscal year on any existing debt;

13 C. As applicable, allocate to each member of the original education unit the  
14 member's share of the annual debt service for the existing debt of the original  
15 education unit in addition to each member's share of costs of the new unit;

16 D. Collect the allocation for debt service on the existing debt from the original  
17 education unit or, as applicable, from each member of the original education unit in  
18 addition to each member's share of costs of the new unit;

19 E. Pay the debt service on the existing debt of the original education unit when due;  
20 and

21 F. Take all other actions necessary and proper with respect to the existing debt.

22 Allocations between members of the original education unit to pay the debt service for  
23 the existing debt must be made on the basis of the cost-sharing formula of the original  
24 education unit in effect on July 1, 2007, as applied to the year of allocation. In the case of  
25 state-subsidized debt service, the provisions of subsection 3 apply. Amounts to pay the  
26 debt service on the existing debt of the original education units must be included in the  
27 budget that the regional school unit board of a new unit submits for approval. If the  
28 original education unit is divided between different new units that have not agreed to  
29 assume liability to pay the existing debt, the commissioner shall require that the  
30 reorganization plan of one of those new units provide for that new unit to serve as agent  
31 for purposes of the existing debt of the original education unit. That new unit, as agent,  
32 has the authority provided by this subsection, except that the new unit shall notify the  
33 other new units containing members of the original education unit of the amounts they  
34 must assess and collect from their members who were members of the original education  
35 unit, and those other new units shall perform the functions in subsection 4, paragraphs C  
36 and D with respect to their members, and shall pay the appropriate amounts over to the  
37 new unit serving as agent.

38 **Sec. A-15. 20-A MRSA §1512, sub-§6**, as enacted by PL 2007, c. 240, Pt.  
39 XXXX, §13, is amended to read:

40 **6. Multiple municipalities.** If a school proposed for closure is ~~an elementary~~ a  
41 school that serves students from more than one municipality, the article set forth in  
42 subsection 1 must be submitted to the voters in each of the municipalities that sent all

1 elementary students from that municipality to the school. If the article is approved by a  
2 majority of the voters in each of the municipalities, the school is not closed and the  
3 municipalities share in the costs under this section in the same proportion as they share

6 SUBCHAPTER 7

7 REORGANIZATION OF REGIONAL SCHOOL UNITS

8 §1516. Dissolution of a district

9 1. Ten percent petition. Upon receipt of a petition that seeks to dissolve a regional  
10 school unit and establishes a maximum figure for the cost of preparing a dissolution  
11 agreement signed by 10% of the number of voters in a municipality who voted at the last  
12 gubernatorial election, the municipal officers of the municipality within the regional  
13 school unit shall call and hold a special election, in the manner provided for the calling  
14 and holding of town meetings or city elections, to vote on the dissolution of the regional  
15 school unit.

16 A. At least 10 days before the election, a posted or otherwise advertised public  
17 hearing on the petition must be held by the municipal officers.

18 B. The petition must be approved by secret ballot by a 2/3 vote of the voters present  
19 and voting before it may be presented to the board of directors and the commissioner.  
20 Voting in towns must be conducted in accordance with Title 30-A, sections 2528 and  
21 2529, even if the towns have not accepted the provisions of Title 30-A, section 2528,  
22 and voting in cities must be conducted in accordance with Title 21-A.

23 2. Form. The article to be voted upon must be in substantially the following form:  
24 "Article: Do you favor filing a petition for dissolution with the directors of regional  
25 school unit (name of regional school unit) and with the Commissioner of Education,  
26 authorizing the dissolution committee to expend \$ (insert amount) and authorizing the  
27 (municipal officers; i.e., selectmen, town council, etc.) to issue notes in the name of  
28 the (name of the municipality) or otherwise pledge the credit of the (name of the  
29 municipality) in an amount not to exceed \$ (insert amount) for this purpose?

30 Yes No"

31 3. Notice of vote; finding by commissioner. If residents of a municipality within  
32 the regional school unit vote favorably on a petition for dissolution, the clerk shall  
33 immediately give written notices, by registered mail, to the secretary of the regional  
34 school unit and the commissioner that must include:

35 A. The petition adopted by the voters, including the positive and negative votes cast;  
36 and

37 B. An explanation by the municipal officers, stating to the best of their knowledge  
38 the reason or reasons why the municipality seeks to dissolve the regional school unit.

1 11. Determination of vote. The town and city clerks shall, within 24 hours of  
2 determination of the result of the vote in the municipality, certify the total number of  
3 votes cast in the affirmative and the total number of votes cast in the negative on the  
4 article to the commissioner.

5 12. Determination of results; execution of agreement. If the commissioner finds  
6 that a majority of the voters voting on the article have voted in the affirmative, the  
7 commissioner shall notify the municipal officers and the directors of the regional school  
8 unit to take steps for the withdrawal in accordance with the terms of the agreement for

14 commissioner shall immediately cause the checklists and all the ballots cast in the  
15 municipality to be collected and kept at the commissioner's office so they may be  
16 recounted by the municipality.

17 B. The town or city clerk of the municipality is authorized to deliver the checklists  
18 and ballots to the commissioner, notwithstanding any other provision of law to the  
19 contrary.

20 C. The commissioner shall resolve any question with regard to disputed ballots.

21 14. Execution of agreement; certified record; certificate of withdrawal. When  
22 the agreement for withdrawal has been put into effect by the municipality, the municipal  
23 officers shall notify the commissioner by certified mail that the agreement of withdrawal  
24 has been executed.

25 15. Indebtedness; indebtedness defined; indebtedness after withdrawal. The  
26 following provisions apply to outstanding indebtedness.

27 A. Whenever a municipality withdraws from a regional school unit having  
28 outstanding indebtedness, the regional school unit remains intact for the purpose of  
29 securing and retiring the indebtedness. The withdrawal agreement may provide for  
30 alternate means for retiring outstanding indebtedness.

31 B. For purposes of this subsection, "outstanding indebtedness" means bonds or notes  
32 for school construction projects issued by the board of directors pursuant to the  
33 authorization established under chapter 609 or Title 20, sections 3457 to 3460 or  
34 obligations to the Maine School Building Authority pursuant to any contract, lease or  
35 agreement made by the board of directors pursuant to approval thereof in a meeting  
36 of the regional school unit, but does not include any indebtedness of the municipality  
37 assumed by the regional school unit at the time of formation nor any contract, lease  
38 or agreement of the Maine School Building Authority to which by operation of law  
39 the regional school unit has become the assignee.

40 16. General purpose aid. When a municipality withdraws from a regional school  
41 unit, the general purpose aid for the municipality must be computed in accordance with  
42 chapter 606-B.

1 17. Committee recall. If the commissioner determines that the withdrawal  
2 committee has failed to comply with the requirements of this section, the commissioner  
3 may authorize the municipal officers to appoint new representatives to the committee.

4 18. Commissioner recommended dissolution. The commissioner's responsibilities  
5 to initiate dissolution proceedings are as follows.

6 A. If a municipality representing more than 50% of the total population in a regional  
7 school unit votes to withdraw from the district, then the commissioner shall analyze

23 C. If the voters approve the article by a majority vote of those voting and present,  
24 then the rest of the dissolution process set forth in section 1516 applies except:

25 (1) A 2nd member from the general public must be selected by the municipal  
26 officers to fill the position on the dissolution committee normally held by a  
27 representative of the group that would have filed the dissolution petition; and

28 (2) Costs of preparing a dissolution agreement must be borne solely by the  
29 regional school unit.

30 19. Transfer of property. The board of directors may negotiate with the  
31 withdrawal committee regarding an equitable division of the regional school unit's  
32 property between the regional school unit and the municipality represented by the  
33 committee and transfer title of the property to the municipality following withdrawal. The  
34 board of directors shall determine that the regional school unit's educational program may  
35 not be disrupted solely because of the transfer of any given property before it may  
36 complete the transfer.

26 which agreements continue in effect for the remainder of their unexpired  
27 terms unless the bargaining agent and the regional school unit mutually agree

34 municipality has transferred shall merge in accordance with the procedures and  
35 criteria in section 1464.

37 of the certificate of transfer in the office of the Secretary of State.

38 **3. Outstanding indebtedness.** Whenever a municipality, or a part of a municipality,

**FORMATION OF REGIONAL SCHOOL UNION**

**§2011. Formation of a regional school union; reorganization planning and approval**

The residents of 2 or more school administrative units may form a regional school union that is a body politic and corporate pursuant to this section.

1. Notice of intent. Each school administrative unit shall file with the commissioner a notice of intent to engage in planning and negotiations with other school administrative units for the purpose of developing a reorganization plan to form a regional school union under this chapter. The commissioner shall respond to each notice of intent providing information regarding the process and whether the intended action complies with the requirements of this chapter.

2. Reorganization planning committee. The school administrative units that intend to engage in planning and negotiation to create a regional school union shall form a reorganization planning committee.

A. For each proposed regional school union, the commissioner shall provide guidelines for the formation of a reorganization planning committee including representation from the school administrative units included in the notice of intent, member municipalities and members of the general public who are residents of the proposed regional school union. The guidelines must include roles and responsibilities of the committee, timelines for submission of the plan, the format for reporting the reorganization plan and evaluation criteria for approval of the plan.

B. Reorganization planning committees shall hold one or more public meetings to gather input from community members and to determine the sentiment of the public.

3. Submission of plans. Each school administrative unit shall submit to the commissioner its proposed reorganization plan for consolidation into a regional school union that meets the requirements of paragraphs A and B.

A. A reorganization plan must include:

- (1) The local education units to be included in the proposed reorganized regional school union;
- (2) The size, composition and apportionment of the governing body;
- (3) The method of voting of the governing body;
- (4) The powers and duties of the regional school union;
- (5) The disposition of real and personal school property;
- (6) The disposition of existing school indebtedness and lease-purchase obligations;
- (7) The assignment of school personnel contracts, school collective bargaining agreements and other school contractual obligations;

- 1           (8) The disposition of existing school funds and existing financial obligations,

19 B. A reorganization plan is approved by the member municipalities of a community  
20 school district that does not provide public education for the entire span of  
21 kindergarten to grade 12 if the majority of votes cast in the member municipalities is  
22 in favor of approval of the plan. Approval results in all member municipalities  
23 joining the regional school union.

24 C. A municipal school unit, including a municipal school unit that is a member of a  
25 school union, approves a reorganization plan if the majority of the votes cast in that  
26 municipality is in favor of approval of the plan.

27 If a reorganization plan is approved by all of the affected school administrative units, or  
28 by the school administrative units considered sufficient under the proposed reorganization  
29 plan, the commissioner shall file notice of approval of the regional school union with the  
30 state board.

31 **7. Certificate of organization.** If a plan or revised plan for reorganization has been  
32 approved by the commissioner and approved by voters at the referendum, the state board  
33 shall issue a certificate of organization to the school administrative units that are  
34 reorganized into a regional school union.

35 **§2012. Transitional powers and duties of the regional school union committee**

36 Within 30 days of the issuance of a certificate of organization for the regional school  
37 union by the state board, the school boards of the local education units shall appoint  
38 members of the regional school union committee in accordance with the approved  
39 reorganization plan. As used in this section, unless the context otherwise indicates,  
40 "regional school union committee" means the initial regional school union committee

27 the length of their probationary period calculated from the date of their most recent

28 **1. Definition of vacancy.** A vacancy on a regional school union committee occurs:

29 A. When the term of office of a regional school union committee member expires;

30 B. When a regional school union committee member changes residency from the

24 receiving the request or the petition.

25 **2. Awaiting census results.** If the commissioner receives a request within 12

27 commissioner may wait until after the new census figures are available to make a  
28 determination under subsection 1.

29 **3. Findings and order.** If the commissioner finds the regional school union  
30 representation is not apportioned in accordance with the one-person, one-vote principle,  
31 the commissioner, within 7 days of that decision, shall notify the superintendent of the  
32 regional school union of the finding and order the superintendent to notify the school  
33 board in each local education unit in the regional school union and the regional school  
34 union committee to create a reapportionment committee. The superintendent's notification  
35 must include the commissioner's notification, the information provided pursuant to  
36 subsection 6 and the time and place for the first meeting of the committee, which must be  
37 held not later than 20 days after the notification.

38 **4. Reapportionment committee membership.** The reapportionment committee  
39 consists of 2 members from each school board, chosen by the respective school boards.

40 **5. Quorum.** A majority of the reapportionment committee constitutes a quorum.

**BUDGET VALIDATION REFERENDUM**

**§2041. Budget validation referendum**

**1. Budget validation referendum.** The annual budget of a regional school union does not become final until it has been approved by the regional school union committee and validated at a budget validation referendum conducted in accordance with this section.

Every 3 years, the voters in the regional school union shall consider the continued use of the budget validation referendum process as provided in section 1486.

**2. Article.** The article to be voted on at a budget validation referendum held pursuant to subsection 1 must be in substantially the following form:

"Do you favor approving the (name of the regional school union) budget for the upcoming school year as approved by the regional school union committee and set forth below?"

If this article is approved, each member will be required to pay from its approved school budget its budget share as shown above to (name of regional school union)."

**3. Procedures.** The budget validation referendum held pursuant to subsection 1 must be conducted in accordance with the following procedures.

A. If each school administrative unit that is a member of a regional school union is required to conduct a budget validation referendum on its annual budget, and if none of the warrants for those budget validation referenda has been signed at the time that the budget of the regional school union is approved by the regional school union committee, the article required in subsection 2 must be included as an additional article at each member's budget validation referendum. The voting on the budget validation article in each member school administrative unit is not required to be conducted on the same day. The return and counting of votes on the budget validation article must be conducted in the same manner as the procedures of section 1503, subsection 3.

B. If a budget validation referendum is not conducted in accordance with paragraph A, the article required by subsection 4 must be submitted to a budget validation referendum called by the regional school union committee. The budget validation

1 referendum must be called and conducted in the same manner as the procedures of  
2 section 1486, subsections 2 and 3.

3 **4. Failure to validate budget.** If a majority of the voters in a regional school union  
4 does not vote in favor of validating the budget approved by the regional school union  
5 committee at a budget validation referendum, the regional school union committee shall  
6 prepare and approve a revised budget at least 10 days after the budget validation  
7 referendum. The revised budget approved by the regional school union committee must  
8 be submitted to the voters for validation at a budget validation referendum conducted in  
9 accordance with this section. The process must be repeated until a budget is approved by  
10 the regional school union committee and validated at referendum. If a budget is not  
11 approved by the regional school union committee and validated at referendum before July  
12 1st of each year, the latest budget approved by the regional school union committee is  
13 automatically considered the budget for operational expenses for the ensuing year until a  
14 final budget is approved by the regional school union committee and validated at a budget  
15 validation referendum.

16 **Sec. C-10. Reorganization planning.** A regional school union, as established in  
17 the Maine Revised Statutes, Title 20-A, chapter 108, is deemed a regional school unit  
18 under Public Law 2007, chapter 240, Part XXXX, section 36 for all purposes including  
19 the goal for the number of regional units and the requirements with respect to the number  
20 of students in each regional unit. The Commissioner of Education shall apply the same  
21 criteria and shall allow the same exceptions for regional school unions as are applied to  
22 regional school units. A reorganization plan for a regional school union is also subject to  
23 the requirements of Public Law 2007, chapter 240, Part XXXX, section 36, subsection 6,  
24 paragraph F that the reorganization plan address how administrative functions, duties and  
25 noninstructional personnel will be reorganized so that the projected expenditures for  
26 system administration, transportation, special education and facilities and maintenance  
27 will not have an adverse impact on the instructional program. A reorganization plan for a  
28 regional school union is subject to the same approval and referendum requirements as  
29 provided in Public Law 2007, chapter 240, Part XXXX, section 36, subsections 8 and 9.

30 **Sec. C-11. Application.** Notwithstanding any provision of law to the contrary,  
31 this Part applies to school administrative units and reorganization planning committees  
32 that, on the effective date of this Part, are engaged in or are required to be engaged in  
33 school reorganization planning pursuant to Public Law 2007, chapter 240, Part XXXX.'

34 **SUMMARY**

35 This unanimous committee of conference amendment replaces the bill and  
36 incorporates Committee Amendment "A" (S-410) as amended by House Amendment "F"  
37 to Committee Amendment "A" (H-718) and House Amendment "E" to Committee  
38 Amendment "A" (H-717) and House Amendment "E" (H-719) to the bill. This  
39 amendment differs from the listed amendments in 2 ways. It removes the delay of the  
40 budget referendum process included in Committee Amendment "A" and it further refines  
41 the population density factor exception in House Amendment "F" to Committee  
42 Amendment "A".

- 1 1. The amendment clarifies the authorization provided to regional planning  
2 committees to negotiate a cost-sharing agreement for those costs of a proposed  
3 regional school unit that are in addition to the local contribution required pursuant to  
4 the Maine Revised Statutes, Title 20-A, section 15690.
- 5 2. The amendment repeals a cross-reference to the unit of law that is repealed in the  
6 bill regarding the requirement that each municipality that is a member of a new  
7 regional school unit contribute a minimum of 2 mills of the municipality's property  
8 fiscal capacity to the total cost of education of the new regional school unit.
- 9 3. The amendment includes language inadvertently left out of the bill regarding the  
10 requirement that the reorganization plan include a process for amending the cost-  
11 sharing formula.
- 12 4. The amendment clarifies the roles of the municipal officers and the school  
13 committee for municipal school units whose municipal charters give authority to  
14 approve the school budget to the municipal officers and establishes the requirements  
15 for calling a budget meeting and the procedures for the budget meeting.
- 16 5. The amendment clarifies the relationship between a regional school unit board and  
17 a local school that seeks to raise additional funds for an elementary school or a  
18 secondary school that is owned or managed by the member municipality. The  
19 amendment also removes 2 references to "elementary" schools in the school closure  
20 provisions to clarify that secondary schools are also subject to these requirements.
- 21 6. The amendment permits the Commissioner of Education to authorize so-called  
22 "doughnut hole" school units that have 1,200 or fewer students and no other available  
23 reorganization partners to form a regional school unit that serves at least 1,000  
24 students if these isolated, rural school units meet certain criteria.
- 25 7. The amendment clarifies the assumption of existing debt that is transferred from  
26 an original education unit to a new regional school unit that is formed after July 1,  
27 2008.
- 28 8. The amendment provides regional school unit boards with the legal authority to  
29 receive and spend state and local funds, including funds for the election of regional  
30 school unit board members and to hire a superintendent prior to the operational date  
31 of the new regional school unit on July 1, 2009.

32 This amendment includes the following from House Amendment "E" to Committee  
33 Amendment "A" (H-717).

- 34 1. Part B of this amendment changes the deadline by which a referendum must be  
35 held to January 15, 2009 and changes dates that are linked to the referendum date by  
36 the same amount of time.
- 37 2. Part C of this amendment authorizes regional school unions as an alternative to the  
38 regional school unit method of school reorganization. A regional school union must  
39 perform certain core functions, which include employment of a superintendent,  
40 performance of all business functions, special education administration,  
41 transportation administration, adoption of a core curriculum and all state and federal  
42 reporting. A regional school union is formed in the same manner as a regional school  
43 unit by means of a reorganization plan prepared by a reorganization planning  
44 committee, with approval of the Commissioner of Education and approval at a

1 referendum. Regional school unions are subject to the same requirements as regional  
2 school units with respect to minimum numbers of students, exceptions to minimum  
3 numbers of students, timelines for submission of reorganization plans, operational  
4 date and applicable penalties. School administrative units that form a regional school  
5 union become "local educational units" with no further responsibility for the  
6 administrative functions, which are taken over by the regional school union.

7 3. This amendment also requires that a budget validation referendum be conducted to  
8 approve the budget for a regional school union.

9 This amendment includes the following from House Amendment "E" to the bill (H-  
10 719).

11 1. The amendment enacts into law provisions regarding reorganization of regional  
12 school units. The new provisions are similar to the Maine Revised Statutes, Title 20-  
13 A, former sections 1403, 1405 and 1406 and allow the dissolution of regional school  
14 units, the withdrawal from a regional school unit by a municipality and the transfer  
15 by a municipality out of one regional school unit into another. The amendment  
16 includes provisions that formerly applied in this area of law authorizing the State  
17 Board of Education to review decisions of the Commissioner of Education and to  
18 make rules concerning the reorganization of the regional school units.

19 2. This amendment clarifies that the procedures set forth for withdrawal from a  
20 regional school unit are available to a municipality prior to the formation of the  
21 regional school unit.

22 3. The amendment also makes technical corrections to align the employment and  
23 collective bargaining provisions of the bill, which apply in the event of dissolution of  
24 a regional school unit or withdrawal or transfer of a single municipality from a  
25 regional school unit, with the employment and collective bargaining provisions  
26 enacted in Public Law 2007, chapter 240, Part XXXX and codified in the Maine  
27 Revised Statutes, Title 20-A, sections 1463 and 1464.

28 This amendment includes the following from House Amendment "F" to Committee  
29 Amendment "A" (H-718).

30 1. This amendment allows a state-approved unit of school administration that was  
31 responsible for operating public schools prior to the reorganization of school  
32 administrative units pursuant to the Maine Revised Statutes, Title 20-A, chapter 103-  
33 A to serve fewer than 1,200 students if the area it serves has fewer than 50 residents  
34 per square mile. This amendment differs from House Amendment "F" to Committee  
35 Amendment "A" by refining the population density exception to require the  
36 Commissioner of Education to lower the 1,200-student requirement when the  
37 commissioner determines that the number is impractical.

## An Act To Amend the Laws Regarding School Funding

### Fiscal Note

Potential future biennium cost increase - General Fund

#### Fiscal Detail and Notes

Providing school administrative units with the option of forming a regional school union that allows for the dispersion of decision making authority to local education units within the regional school union except for certain core functions may increase the total cost of K-12 public education in future biennia due to less savings being achieved versus what was anticipated in Public Law 2007, chapter 240, Part XXXX. The amount can not be determined at this time and will depend on the number of regional school unions established and the ability of regional school unions and local education units within the regional school union to implement efficiencies.

Allowing for the dissolution of a regional school unit or a regional school unit member from a regional school unit and for certain school administrative units to serve fewer than 1,200 students if the area it serves has fewer than 50 residents per square mile may also increase the total cost of K-12 public education in future biennia due to less than anticipated savings being achieved. The amount can not be determined at this time and will depend on actual experience.

One area which could impact future General Fund costs is special education. Title 20-A, §15681-A, sub-§2(D) requires that school administrative units receive sufficient funds for special education to ensure that the SAUs meet the federal maintenance of effort requirement for receiving federal Individuals with Disabilities Act funds. The maintenance of effort requirement states that the total amount of state and local funds budgeted by the local education agency for expenditures in a current fiscal year for the education of children with disabilities must be at least equal to the total amount of state and local school funds actually expended for the education of children with disabilities in the most recent preceding fiscal year. Less savings being achieved versus what was anticipated in Public Law 2007, chapter 240, Part XXXX may require a higher level of state and local funding in order to fulfill the maintenance of effort requirement.

A second area is transportation. Title 20-A, §15681-A, sub-§3 requires that school administrative units receive no less than 90% of the most recent year's reported net transportation expenditures. Less savings being achieved versus what was anticipated in Public Law 2007, chapter 240, Part XXXX may require a higher level of funding in order to meet the statutory requirement.

Finally, although this legislation will not impact the total state and local cost of funding K-12 public education, beginning in fiscal year 2008-09 it may affect the distribution of subsidy to local school administrative units with some units receiving more subsidy and some units receiving less subsidy. The impact to individual school administrative units can not be determined at this time.
