COMMITTEE AMENDMENT "A" to H.P. 1374, L.D. 1940

- 1 in fact transacts no business. The name of a limited liability company remains in the
- 2 Secretary of State's records of entity names and is protected for a period of 5 years

- 4 Sec. 6. 31 MRSA §757, sub-§5 is enacted to read:

5 5. Resume transaction of business. The managers or, if no managers, members of 6 a domestic limited liability company that has been excused from filing annual reports 7 pursuant to subsection 4 may vote to resume transacting business at a meeting duly called 8 and held for that purpose. A certificate executed and filed as provided in section 627 9 setting forth that a meeting was held, the date and location of the meeting and that a 10 majority of the managers or, if no managers, members voted to resume transacting 11 business authorizes that domestic limited liability company to transact business. After 12 that certificate is filed, the domestic limited liability company is required to file annual 13 reports beginning with the next reporting deadline following resumption.'

SUMMARY

This amendment limits the ability of limited liability companies to temporarily withdraw from transacting business and avoid filing with the State during the dormant period to those limited liability companies organized in Maine; the benefit is not available to foreign limited liability companies. This is consistent with similar provisions in the business corporation laws.

This amendment requires a domestic limited liability company to go through appropriate procedures and file a certificate of resumption with the Secretary of State before it may resume business activities. This is consistent with the business corporation laws.

This amendment requires a domestic limited liability company to pay the same fees for filing certificates of excuse and resumption of business certificates as are imposed on business corporations.
