#### Fiscal Detail and Notes

The General Fund revenue increase from tax effects associated with the repeal of the ban on hard snuff is \$24,868 in fiscal year 2009-10 and \$25,365 in fiscal year 2010-2011.

The additional administrative costs associated with this change can be absorbed by Maine Revenue Services utilizing existing budgeted resources.
