9 COMMITTEE AMENDMENT "A" to S.P. 779, L.D. 1985, Bill, "An Act To Meet 10 the Emergency Needs of Maine Veterans"

11 Amend the bill by striking out everything after the enacting clause and before the 12 emergency clause and inserting the following:

13 'Sec. 1. 37-B MRSA §505, sub-§1-A, as enacted by PL 2001, c. 439, Pt. QQ, §2,
14 is amended to read:

15 **1-A. Financial assistance.** Financial assistance may be granted as follows.

A. The bureau may provide a grant of temporary assistance not to exceed \$200 per month and not to exceed \$600 in any 12 month period to a veteran in this State who has filed a valid claim for a veteran's pension, pending notification of the award of such a pension, if that veteran is not incarcerated or a permanent resident of a nursing home and requests such assistance. For purposes of this paragraph, "claim for a veteran's pension" means a claim filed with the federal Veterans' Administration pursuant to 38 United States Code, Chapter 15.

23 Β. The bureau may provide a grant of emergency assistance not to exceed \$500 to a 24 veteran who demonstrates to the bureau's satisfaction a financial need and suffers an 25 emergency, such as the loss of damage to that veteran's home due to fire, flood or 26 hurricane, that is not fully compensable by insurance; illness or the illness of an 27 immediate family member; or a similar emergency. In the case of a veteran with terminal illness or catastrophic injury, the director may provide a grant of up to 28 29 <u>\$1,000</u>. No more than \$1,000 in emergency assistance may be provided to a veteran 30 in any 12-month period. For the purposes of this paragraph, "veteran" has the same 31 meaning as "eligible veteran" in section 504, subsection 4, paragraph A-1. Grants 32 may not be issued for fuel assistance or due to loss of income due to unemployment 33 while the veteran is receiving other unemployment benefits.

C. A veteran who requests either temporary assistance under paragraph A or
 emergency assistance under paragraph B and is denied such assistance may request a
 reconsideration and review of this decision by the director. The <u>Requests for</u>

reconsideration of a claim must be reviewed by the director and the commissioner or the commissioner's designee, and the decision of the director after the reconsideration is final and may not be appealed to a court.
