COMMITTEE AMENDMENT "A" to H.P. 1484, L.D. 2098, Bill, "An Act To Prevent and Treat Cancer in Maine by Providing a Source of Funding for a Comprehensive Cancer Prevention Program"

Amend the bill by striking out all of section 5 (page 2, lines 1 to 11 in L.D.) and inserting the following:

Sec. 5. Transfer of funds. Notwithstanding any other provision of law, the State Controller shall transfer \$600,000 in fiscal year 2008-09 from the Bureau of Medical Services, Federal Block Grant Fund account to the Fund for a Healthy Maine no later than June 30, 2009 to fund the Department of Health and Human Services, Bureau of Health's comprehensive cancer screening, detection and prevention program.

Sec. 6. Appropriations and allocations. The following appropriations and allocations are made.

HEALTH AND HUMAN SERVICES, DEPARTMENT OF (FORMERLY DHS)

FHM - Bureau of Health 0953

Initiative: Allocates funds on a one-time basis for the costs of the comprehensive cancer screening, detection and prevention program under Public Law 2007, chapter 341.
