20 21	1. Financial certificate. The portion of Part II of the rule designated as Section 5.1 Certificate 038: Financial Services Manager is not authorized for final adoption; and

The portion of Part II of the rule designated as Section 1.16 Endorsement 081: Early Childhood Teacher is amended to establish eligibility for that endorsement for any person who was employed as a teacher in a prekindergarten or kindergarten to 3rd grade program in the State at any time between February 1, 2007 and February 1, 2008.
