1 Be it enacted by the People of the State of Maine as follows:

31 Sec. 2. 11 MRSA §2-106, sub-§(5) is enacted to read:

32 (5). Service contract. As used in this Article, "service contract" means a contract in
33 writing to perform, over a fixed period of time or for a specified duration, services
34 relating to the maintenance or repair, or both, of a consumer product.

35 Sec. 3. 11 MRSA §2-314-A is enacted to read:

1 §2-314-A. Notification of implied warranty

A seller of consumer goods, with the exception of new and used motor vehicles, who also offers for sale service contracts shall instruct the seller's employees who deal with buyers of the requirements of the State's laws governing implied warranties pursuant to section 2-314, section 2-315 and section 2-316, subsection (5).

6 Sec. 4. Attorney General to publish brochure. The Attorney General shall 7 publish a brochure that describes the protections in the State's implied warranty laws and 8 provide it at no cost to sellers of consumer goods.

SUMMARY

10 This bill requires sellers of consumer goods who offer service contracts for sale to 11 instruct their employees who deal with buyers of the requirements under the State's 12 implied warranty laws. It also requires the Attorney General to publish a brochure on the 13 State's implied warranty laws and to provide copies at no cost to sellers of consumer 14 goods.
