Beginning with the plans updated in 2009, each department agency and instrumentality of the State shall submit the plans to the Director of the Bureau of Human Resources within the Department of Administrative and Financial Services;

The report must include any changes made to the plans, an assessment made by the director of the effectiveness of the plans and any recommendations for legislative action pertaining to the report. The joint standing committee of the Legislature having jurisdiction over state and local government matters may submit legislation pertaining to the report to the first

This amendment replaces the bill. The amendment requires all departments, agencies and instrumentalities of the State to submit their plans to increase the opportunities for individuals with disabilities to be hired in each unit to the Director of the Bureau of Human Resources within the Department of Administrative and Financial Services. The director shall submit a report on the plans to the joint standing committees of the Legislature having jurisdiction over state and local government matters and labor matters by March 1, 2009 and biennially after that. The report must include any changes to the plans, an assessment made by the director of the effectiveness of the plans and any proposed legislation. The report must also be submitted to the Governor's office.
