HOUSE AMENDMENT "C" to COMMITTEE AMENDMENT "A" to S.P. 838, 8 L.D. 2178, Bill, "An Act To Increase Public Confidence in Government by Expanding 9 10 Public Disclosure"

11 Amend the amendment in section 1 in subsection 4 in the 2nd and 3rd lines (page 1, lines 16 and 17 in amendment) by striking out the following: ", the range of income 12 13 derived from each source"

14 Amend the amendment by striking out all of section 2 (page 1, lines 22 to 34 and 15 page 2, lines 1 to 34 in amendment) and inserting the following:

16 'Sec. 2. 1 MRSA §1016-E is enacted to read:

17 §1016-E. Disclosure of interests

18 Beginning in 2010, each Legislator shall file with the commission by 5:00 p.m. on 19 February 15th of each year on the form provided by the commission a statement of those 20 positions set forth in this section that were held in the preceding calendar year. Prior to 21 the end of the first week in January of each year, the commission shall deliver a form to 22 each Senator and member of the House of Representatives. The statement of positions is 23 a public record.

24 1. Disclosure of officer or director position. A Legislator filing a statement under 25 this section shall report:

- A. Any offices, trusteeships, directorships or positions of any nature, whether 26 27 compensated or uncompensated, held by the Legislator in the preceding calendar year 28 with any for-profit or nonprofit firm, corporation, association, partnership or
- 29 business; and

- 30 B. Any offices, trusteeships, directorships or positions of any nature, whether 31 compensated or uncompensated, held by a member of the immediate family of the 32 Legislator with any for-profit or nonprofit firm, corporation, association, partnership 33 or business and the name of that member of the Legislator's immediate family.
- 34 Amend the amendment in section 5 in subsection 2 in paragraph D in the 2nd line 35 (page 3, line 30 in amendment) by striking out the following: ", a range of income 36 derived from each source"

HOUSE AMENDMENT C" to COMMITTEE AMENDMENT "A" to S.P. 838, L.D. 2178

Amend the amendment by striking out all of sections 6 and 7 (page 4, lines 6 to 41 and page 5, lines 1 to 3 in amendment) and inserting the following:

- 3 'Sec. 6. 5 MRSA §19, sub-§2-A is enacted to read:
- 4 **2-A.** Statement of interests. Beginning in 2010, each executive employee shall 5 annually file with the Secretary of State a sworn and notarized statement of those 6 positions set forth in this subsection for the preceding calendar year. The statement must 7 include:

A. Any offices, trusteeships, directorships or positions of any nature, whether
compensated or uncompensated, held by the executive employee with any for-profit
or nonprofit firm, corporation, association, partnership or business; and

B. Any offices, trusteeships, directorships or positions of any nature, whether compensated or uncompensated, held by a member of the immediate family of the executive employee with any for-profit or nonprofit firm, corporation, association, partnership or business and the name of that member of the executive employee's

Amend the amendment by striking out all of section 11 (page 5, lines 20 to 25 in amendment)

18 Amend the amendment by relettering or renumbering any nonconsecutive Part letter19 or section number to read consecutively.

SUMMARY

This amendment removes the requirement that Legislators and certain executive branch employees disclose the range of income derived from each source with respect to income earned by immediate family members of Legislators and certain executive branch employees. It also removes the requirement that Legislators and certain executive branch employees disclose certain real property and investment interests.
