It clarifies that departments must either post proposed and adopted rules on the departmental website or post a link to the rules on the Secretary of State's website. The amendment changes the redesign provisions in the bill to reflect the fact that MAPA-3 and MAPA-4 are the correct notices to be redesigned and |
