Requiring a transfer from the General Fund to the Highway Fund will increase the General Fund cost of the bill by \$7,262,500 in fiscal year 2008-09. This amendment also increases Highway Fund revenue by \$4,357,500 in fiscal year 2007-08 and decreases Highway Fund revenue by \$4,357,500 in fiscal year 2008-09.
