A historic preservation representative, recommended by the Maine Historic 26 Preservation Commission, with experience implementing the standards for the 27 treatment of historic properties set forth in 36 Code of Federal Regulations, Part 68 28 (2007), who is: 29 (1) An architect licensed in the State; 30 (2) A structural engineer licensed in the State; or 31 (3) A builder; 32 I. An energy efficiency representative, recommended by the director of the 33 Governor's Office of Energy Independence and Security within the Executive 34 Department, who has experience or expertise in the design or implementation of 35 energy codes or in the application of energy efficiency measures in residential or 36 commercial construction; 37 J. A mechanical engineer licensed in the State, recommended by a statewide association of mechanical engineers; and 38 K. The Commissioner of Public Safety, or the 4 commissioner's designee, serves as an ex officio member and as the chair of the board. 5 The chair is a nonvoting member, except in the case of a tie of the board. <u>4. Terms; removal.</u> Appointments to the board are made for a 4-year term, and

 the board may be removed from the board for cause by the Governor.

5. Meetings; quorum. The board shall meet quarterly and at such other times as the
 board determines necessary. Seven voting members of the board constitute a quorum for
 the transaction of business under this chapter.

17 6. Duties and powers. In addition to other duties set forth in this chapter, the board
 18 shall:

19A. Adopt rules in accordance with the Maine Administrative Procedure Act20necessary to carry out its duties under this chapter. Rules adopted pursuant to this21chapter are routine technical rules as defined in Title 5, chapter 375, subchapter 2-A;

 25, section 2372, to develop a training program for municipal building officials, local
 code enforcement officers and 3rd-party inspectors. The Executive Department, State

3. Annual review. The committee shall annually review the training program developed pursuant to subsection 2 to confirm that training courses are regularly offered in geographically diverse locations and that training for municipal building officials is fully funded by the State.

26 <u>1. Limitations on home rule authority. This chapter provides express limitations</u>
 27 <u>on municipal home rule authority.</u>

28 2. Ordinances. Effective July 1, 2010, except as provided in subsection 3 and 29 section 9725, any ordinance regarding a building code of any political subdivision of the 30 State that is inconsistent with the Maine Uniform Building Code is void. Beginning July 1, 2010, the code may be enforced in a municipality that has more
 than 2,000 residents and that has adopted any building code by August 1, 2008.
 Beginning July 1, 2012, the code may be enforced in a municipality that has more than
 2,000 residents and that has not adopted any building code by August 1, 2008. The code
 may be enforced through inspections that comply with the code through any of the
 following means:
 Building officials. Building officials and local code enforcement officers;

- 2. Interlocal agreements. Interlocal agreements with other municipalities that share
 the use of building officials certified in building standards pursuant to Title 10, section

SUMMARY

This amendment is the minority report of the committee.

1. It establishes the Maine Uniform Building Code and removes references in the code to the International Energy Conservation Code and the Maine model radon standard for new residential construction set forth in the Maine Revised Statutes, Title 25, section 2466 and associated rules.

7 2. It amends the membership of the Technical Building Codes and Standards Board8 in the Department of Public Safety.

9 3. It provides the board with the authority to resolve conflicts only between the 10 Maine Uniform Building Code and the fire and life safety codes.

4. It requires the board to adopt rules in accordance with the Maine Administrative
Procedure Act necessary to carry out its duties and sunsets the duties of the board in
January 2012.

5. It requires the board on December 31st of each calendar year beginning in 2010 to report to the joint standing committee of the Legislature having jurisdiction over business, research and economic development matters any proposals for proposed conflict resolutions for codes and standards referenced in Title 10, section 9725, subsections 2 to 7; proposals to improve the efficiency and effectiveness of those codes and standards; and alternative methods of funding for the board to create an equitable source of revenue.

6. It changes the establishment of the Division of Building Codes and Standards in
the Department of Public Safety, instead establishing it as an independent bureau within
the Department of Public Safety.

7. It removes mandatory enforcement of the Maine Uniform Building Code and
provides that municipalities may choose to enforce the Maine Uniform Building Code
through inspections that comply with the code through any of the following means:

27 A. Building officials and local code enforcement officers;

B. Interlocal agreements with other municipalities that share the use of building
officials certified in building standards pursuant to Title 10, section 9723;

C. Contractual agreements with county or regional authorities that share the use of
 building officials certified in building standards pursuant to Title 10, section 9723;
 and

D. Reports from 3rd-party inspectors certified pursuant to Title 10, section 9723 submitted to the building official that are obtained pursuant to independent contractual arrangements between the building owner and 3rd-party inspector or the municipality and 3rd-party inspector.

Fiscal Detail and Notes

This bill establishes a new program, the Bureau of Building Codes and Standards, within the Department of Public Safety. The Bureau is charged with providing administrative support and technical assistance to the Technical Building Codes and Standards Board, which is established to adopt, amend and maintain the Maine Uniform Building Code. The Department of Public Safety will require an Other Special Revenue Funds allocation of \$293,618 for a Bureau Director and clerical position, technology and other related costs. A Planner II position within the State Planning Office is funded by the Bureau and the costs of that position, \$18,429 in fiscal year 2008-09, will be transferred to the Bureau. The allocation and the transfer of costs from the State Planning Office are funded by a surcharge on new construction, reconstruction, repairs, renovations and new use which will be deposited into a newly created fund, the Uniform Building Codes and Standards Fund. It is estimated that this surcharge will result in additional Other Special Revenue Funds of \$312,400 in fiscal year 2008-09.
