SUMMARY

9 This amendment incorporates House Amendment "A" to Committee Amendment "A" but strikes the provision that requires the Executive Department, Governor's Office of 10 Energy Independence and Security to assist the Department of Administrative and 11 12 Financial Services, Bureau of General Services in identifying and planning for the construction of wind and other renewable electricity generation projects. It also strikes 13 14 the appropriations and allocations section.
