HOUSE AMENDMENT "A" to H.P. 1651, L.D. 2289, Bill, "An Act Making Supplemental Appropriations and Allocations for the Expenditures of State Government and To Change Certain Provisions of the Law Necessary to the Proper Operations of State Government for the Fiscal Years Ending June 30, 2008 and June 30, 2009"

Amend the bill by striking out all of Part LLLL and inserting the following:

PART LLLL

**Sec. LLLL-1. Legislative account; lapsed balances; Office of Program Evaluation and Government Accountability - General Fund.** Notwithstanding any other provision of law, \$16,517 of unencumbered balance forward in the Personal Services line category and \$300,964 in the unencumbered balance forward in the All Other line category in the Office of Program Evaluation and Government Accountability General Fund account in the Legislature lapses to the General Fund in fiscal year 2008-09.

**Sec. LLLL-2. Appropriations and allocations.** The following appropriations and allocations are made.



This amendment will decrease the General Fund cost of the bill by \$195,000 in fiscal year 2007-08 and will increase the General Fund cost fo the bill by \$303,773 in fiscal year 2008-09. Based on the estimated year-end balances, this amendment maintains a balanced budget for the 2008-2009 biennium.
