HOUSE AMENDMENT "F" to H.P. 1651, L.D. 2289, Bill, "An Act Making Supplemental Appropriations and Allocations for the Expenditures of State Government and To Change Certain Provisions of the Law Necessary to the Proper Operations of State Government for the Fiscal Years Ending June 30, 2008 and June 30, 2009"

Amend the bill in Part HHH in section 1 in the 2nd line (page 340, line 3 in L.D.) by striking out the following: "\$2,500,000" and inserting the following: '\$800,000'

Amend the bill in Part HHH in section 1 by adding a new 2nd paragraph to read:

'Notwithstanding any other provision of law, the State Controller shall transfer \$1,700,000 of surplus funds not needed for current operations by June 30, 2008 from the Department of Administrative and Financial Services, Bureau of General Services - Capital Construction Reserve Fund, Other Special Revenue Funds account to the Highway Fund for emergency road repairs.'

SUMMARY

This amendment reduces the transfer from the Department of Administrative and Financial Services, Bureau of General Services - Capital Construction Reserve Fund, Other Special Revenue Funds account to the unappropriated surplus of the General Fund by \$1,700,000 and allocates \$1,700,000 to the Highway Fund for emergency road repairs.

Fiscal Detail and Notes

This amendment will increase the General Fund cost of the bill by \$1,700,000 in fiscal year 2007-08. Based on the estimated year-end balances, this amendment would reduce resources below estimated ending balances and a balanced budget is not maintained for the 2008-2009 biennium.

This amendment increases Highway Fund resources by \$1,700,000 in fiscal year 2007-08.
