11 12	Amend the bill by striking out all of section 4 (page 1, lines 33 to 38 and page 2, lines 1 to 12 in L.D.)
13 14	Amend the bill in section 7 in paragraph A in the 2nd line (page 3, line 25 in L.D.) by striking out the following: "last" and inserting the following: 'l1th'
15 16	Amend the bill in section 8 in paragraph A in the first line (page 3, line 30 in L.D.) by striking out the following: "75" and inserting the following: '100'
17 18	Amend the bill in section 10 in §765 in the indented paragraph in the 5th line (page 4, line 16 in L.D.) by striking out the following: "30" and inserting the following: '45'
19 20	Amend the bill in section 19 in subsection 1 in the last line (page 7, line 39 in L.D.) by striking out the following: "75" and inserting the following: '100'
21 22	Amend the bill in section 30 in subsection 2 in the 3rd line (page 11, line 8 in L.D.) by striking out the following: "45" and inserting the following: '50'
23 24	Amend the bill by relettering or renumbering any nonconsecutive Part letter or section number to read consecutively.
25	SUMMARY
26 27 28 29	This amendment strikes out the section of the bill that would have changed the date for payment of tax from the following September to the 9th month of the county's fiscal year. This section of law does not need to be changed to allow counties to change their fiscal year.
30 31	The other sections of the amendment standardize sections to match other specified numbers of days in the bill.
