HOUSE AMENDMENT "A" to H.P. 1668, L.D. 2308, Bill, "An Act To Stabilize the Department of Inland Fisheries and Wildlife's Bureau of Warden Service and Fisheries and Hatcheries Division"

Amend the bill by striking out the title and substituting the following:


**'An Act To Stabilize the Department of Inland Fisheries and Wildlife'**

Amend the bill by striking out everything after the enacting clause and before the summary and inserting the following:

**'Sec. 1. Transfer; Department of Inland Fisheries and Wildlife.** The State Controller shall transfer the \$650,000 that the State Controller was authorized to transfer to the Administrative Services - Inland Fisheries and Wildlife program pursuant to Public Law 2007, chapter 240, Part LLLL, section 4 back to the Department of Inland Fisheries and Wildlife carrying account.'

**SUMMARY**

This amendment directs the State Controller to transfer \$650,000 to the Department of Inland Fisheries and Wildlife carrying account that was transferred to the Department of Inland Fisheries and Wildlife Administrative Services - Inland Fisheries and Wildlife program pursuant to Public Law 2007, chapter 240, Part LLLL, section 4.
