17 18	1. Definitions. As used in this section, unless the context otherwise indicates, the following terms have the following meanings:
19	A. "Enclosed area" has the same meaning as in section 1541, subsection 2;
20	B. "Public place" has the same meaning as in section 1541, subsection 4;
21	C. "Smoking" has the same meaning as in section 1541, subsection 6;
22 23	D. "State historic site" has the same meaning as "historic site" in Title 12, section 1801, subsection 5; and
24 25	E. "State park" has the same meaning as "park" in Title 12, section 1801, subsection 7.
26 27 28	2. Smoking prohibited. A person may not smoke tobacco or any other substance in, on or within 20 feet of a beach, playground, snack bar, group picnic shelter, business facility, enclosed area, public place or restroom in a state park or state historic site.
29 30 31	3. Signs; public education. To the extent possible within existing budgeted resources, the Maine Center for Disease Control and Prevention shall erect signs and undertake public education initiatives regarding the prohibition on smoking in certain areas of state parks and state historic sites!

### **SUMMARY**

This amendment adds definitions and amends the bill to prohibit smoking in, on or within 20 feet of a beach, playground, snack bar, group picnic shelter, business facility, enclosed area, public place or restroom in a state park or state historic site. The amendment requires the Maine Center for Disease Control and Prevention to erect signs and undertake public education initiatives regarding the prohibition to the extent of available resources.

### **Fiscal Note**

#### **Fiscal Detail and Notes**

The bill requires the Maine Centers for Disease Control and Prevention in the Department of Health and Human Services, to the extent possible within existing budgeted resources, to erect signs and undertake public education initiatives regarding the prohibition on smoking in certain areas of state parks and historic sites. The Department estimates the approximate costs of these efforts could be \$10,000 if sufficient funds are available within budgeted resources. Additional costs to the Department of Conservation can be absorbed within existing budgeted resources.
