1 **Be it enacted by the People of the State of Maine as follows:**

2 **Sec. 1. 12 MRSA §13071-A, sub-§4, ¶A**, as enacted by PL 2003, c. 655, Pt. B,
3 §384 and affected by §422, is amended to read:

4 A. A person may not operate a personal watercraft on:

5 (1) Mud Pond, Oversett Pond, South Pond, Round Pond, Twitchell Pond, Hicks
6 Pond, Indian Pond or Furlong Pond in the Town of Greenwood in Oxford
7 County;

8 (2) North Pond or Bryant Pond, also known as Christopher Lake, in the Town of
9 Greenwood and the Town of Woodstock in Oxford County;

10 (3) Concord Pond, Little Concord Pond or Shagg Pond in the Town of
11 Woodstock in Oxford County;

12 (4) Hamilton Pond in Bar Harbor in Hancock County;

13 (5) Bog Lake or Horseshoe Lake in the Town of Northfield in Washington
14 County;

15 (6) Megunticook Lake in the Town of Camden and the Town of Hope in Knox
16 County and the Town of Lincolnville in Waldo County;

17 (7) Hobbs Pond, Fish Pond or Alford Lake in the Town of Hope in Knox
18 County;

19 (8) Norton Pond or Coleman Pond in the Town of Lincolnville in Waldo County;

20 (9) Pitcher Pond in the Town of Lincolnville and the Town of Northport in
21 Waldo County;

22 (10) Torsey Lake in the Town of Mount Vernon and the Town of Readfield in
23 Kennebec County;

24 (11) Trickey Pond in the Town of Naples in Cumberland County;

25 (12) Brandy Pond in the Town of Naples in Cumberland County between sunset

27 (13) Fulton Lake in the Town of Northfield in Washington County;

30 (16) Tripp Pond, Upper Range Pond or Middle Range Pond in the Town of

32 (17) Keewaydin Lake, Virginia Lake, Trout Pond, Weymouth Pond or Whitney
33 Pond in the Town of Stoneham in Oxford County;

34 (18) Lermond Pond in the Town of Union and the Town of Hope in Knox

36 (19) Pocasset Lake or Pickerel Pond in the Town of Wayne in Kennebec County;
