11 Amend the bill in the emergency preamble in the 4th whereas paragraph (page 1, line  
12 10 in L.D.) by striking out the following: "6" and inserting the following: '4'

13 Amend the bill in the emergency preamble in the 6th whereas paragraph (page 1, line  
14 15 in L.D.) by striking out the following: "6" and inserting the following: '4'

15 Amend the bill in section 1 in the 9th line (page 1, line 31 in L.D.) by striking out the  
16 following: "\$193,988" and inserting the following: '\$164,015'

17 Amend the bill in section 1 in the 11th line (page 1, line 33 in L.D.) by striking out  
18 the following: "\$193,988" and inserting the following: '\$164,015'

**SUMMARY**

20 This amendment corrects the amount necessary to provide one-time funds to  
21 subsidize the purchase of military service credit for the members of the Maine Public  
22 Employees Retirement System who applied and were determined eligible to purchase the  
23 service credit for calendar year 2004 per Public Law 2003, chapter 693. The amendment  
24 is necessary because the original calculation was based on 6 individuals who are eligible.  
25 Since 2 of those individuals have already retired, the new calculation is based on the 4  
26 remaining individuals who were determined eligible to purchase service credit for  
27 calendar year 2004.

#### Fiscal Detail and Notes

This bill includes a one-time General Fund appropriation of \$164,015 in fiscal year 2008-09 to the Maine Public Employees Retirement System (MainePERS) for the cost associated with subsidizing the purchase of military service credit for 4 members who were determined to be eligible in calendar year 2004 pursuant to Public Law 2003, Chapter 693.
