24 25 26 27 28 29	This amendment clarifies that no General Fund money may be used for design, construction, installation and maintenance of the memorial for families and friends of children who have died by violence. It also directs the Director of the Bureau of General Services within the Department of Administrative and Financial Services to establish an account for the administration of funds, gifts and other contributions accepted by the Capitol Planning Commission for the memorial.
