COMMITTEE AMENDMENT "A" to S.P. 140, L.D. 398, Bill, "An Act To Transfer Ownership and Management of Swan Island and Little Swan Island in Perkins Township, Sagadahoc County to the Department of Conservation"

Amend the bill by striking out the title and substituting the following:

**'Resolve, To Develop a Management Plan for the Nonwildlife Components of Swan Island and Little Swan Island in Perkins Township, Sagadahoc County'**

Amend the bill by striking out everything after the title and before the summary and inserting the following:

**'Sec. 1. Creation of a stakeholder group; membership and memorandum of agreement. Resolved:** That the Department of Inland Fisheries and Wildlife and the Department of Conservation, referred to in this resolve as "the departments," shall establish and convene a stakeholder group to evaluate the options available to manage the nonwildlife components of Swan Island and Little Swan Island in Perkins Township, Sagadahoc County. The stakeholder group shall consider and, when possible, build upon the 1999 master plan for Swan Island in conducting its work pursuant to this section. The departments shall develop and enter into a memorandum of agreement for the management of the nonwildlife components of the islands based on the recommendations and findings of the stakeholder group. The stakeholder group consists of:

1. The Commissioner of Inland Fisheries and Wildlife or the commissioner's designee;
2. The Commissioner of Conservation or the commissioner's designee;
3. A person representing the Town of Richmond;
4. A person or persons representing an adjacent municipality that expresses an interest in participating in the stakeholder group;
5. A person representing a nonprofit organization with the mission of preserving and protecting the ecosystem of Merrymeeting Bay;

1 6. A person representing a nonprofit organization that works to improve and  
2 promote Swan Island;

3 7. A person representing a business from the local community near Swan Island;

4 8. A person representing an historic preservation organization involved with or  
5 having a current interest in Swan Island;

6 9. A person from a state agency with a current interest in the management of Swan  
7 Island; and

8 10. A person not from a state agency with a current interest in the management of  
9 Swan Island.

10 The departments shall ensure that a balance of interests is present on the stakeholder  
11 group; and be it further

12 **Sec. 2. Report. Resolved:** That no later than February 1, 2010 the departments  
13 shall report the findings and recommendations of the stakeholder group established in this  
14 resolve and the memorandum of agreement developed between the departments as a  
15 result of the stakeholder group's findings and recommendations to the Joint Standing  
16 Committee on Inland Fisheries and Wildlife. The report must include any draft  
17 legislation needed to carry out the recommendations contained in the report. The Joint  
18 Standing Committee on Inland Fisheries and Wildlife may submit legislation to the  
19 Second Regular Session of the 124th Legislature regarding the report. '

20 **SUMMARY**

21 This amendment replaces the bill with a resolve and directs the Department of Inland  
22 Fisheries and Wildlife and the Department of Conservation to establish a stakeholder  
23 group to evaluate the options available for the management of the nonwildlife  
24 components of Swan Island and Little Swan Island. It directs the departments to develop  
25 and enter into a memorandum of agreement for the management of the nonwildlife  
26 components of the islands based on the recommendations and findings of the stakeholder  
27 group. This amendment provides that by February 1, 2010 the departments shall report  
28 findings and recommendations of the stakeholder group and provide the departments'  
29 memorandum of agreement to the Joint Standing Committee on Inland Fisheries and  
30 Wildlife. It authorizes the Joint Standing Committee on Inland Fisheries and Wildlife to  
31 submit legislation to the Second Regular Session of the 124th Legislature based on that  
32 report.
