Fiscal Detail and Notes

Removing the emergency clause on this bill, which the fiscal note now assumes will extend the effective date to October 1, 2009, will delay the Other Special Revenue Funds revenue increase by \$396 in fiscal year 2008-09 and \$1,188 in fiscal year 2009-10. This amendment decreases the Other Special Revenue Funds allocation by a corresponding amount.
