**An Act To Suspend the Cost-of-living Adjustment for Legislators'
Salaries for the Second Regular Session of the 124th Legislature**

1 **Be it enacted by the People of the State of Maine as follows:**

2 **Sec. 1. 3 MRSA §2, first ¶**, as amended by PL 2003, c. 20, Pt. F, §1, is further
3 amended to read:

4 Each member of the Senate and House of Representatives, beginning with the first
5 Wednesday of December 2000 and thereafter, is entitled to \$10,815 in the first year and
6 \$7,725 in the 2nd year of each biennium, except that if a Legislator who is a recipient of
7 retirement benefits from the federal Social Security Administration files a written request
8 with the Executive Director of the Legislative Council within one week after the
9 biennium commences, the Legislator is entitled to \$9,270 in each year of the biennium.
10 Each member of the Senate and the House of Representatives must receive a cost-of-
11 living adjustment in annual legislative salary, except that the percentage increase may not
12 exceed 5% in any year. Beginning December 1, 2001, the salary for each legislative
13 session must be adjusted each December 1st by the percentage change in the Consumer
14 Price Index for the most recently concluded fiscal year; except that no member of the
15 Senate or the House of Representatives may receive a cost-of-living adjustment in annual
16 legislative salary for the Second Regular Session of the 121st Legislature or the First
17 Regular Session of the 122nd Legislature or the Second Regular Session of the 124th
18 Legislature. In addition, each Legislator is entitled to be paid for travel at each legislative
19 session once each week at the same rate per mile to and from that Legislator's place of
20 abode as state employees receive, the mileage to be determined by the most reasonable
21 direct route, except that Legislators may be reimbursed for tolls paid for travel on the
22 Maine Turnpike as long as they have a receipt for payment of the tolls, such tolls to be
23 reimbursed when Legislators use the Maine Turnpike in traveling to and from sessions of
24 the Legislature or in performance of duly authorized committee assignments. Each
25 Legislator is entitled to mileage on the first day of the session, and those amounts of
26 salary and expenses at such times as the Legislature may determine during the session,
27 and the balance at the end of the session.

28 **SUMMARY**

29 This bill suspends the cost-of-living adjustment for salaries of Legislators for the
30 Second Regular Session of the 124th Legislature.
