This bill includes General Fund deappropriations of \$276,631 in fiscal yeat 2009-10 and \$382,382 in fiscal year 2010-11 and Financial and Personnel Services Fund deallocations of \$754,340 in fiscal year 2009-2010 and \$1,027,161 in fiscal year 2010-11 due to the elimination of 13 positions within the Department of Administrative and Financial Services and the Executive Department.
