SUMMARY

This amendment changes the bill to a resolve and changes the title. It directs the Maine Health Data Organization and the Governor's Office of Health Policy and Finance to convene a working group, including representatives of the Maine Hospital Association, the Maine Health Data Organization and the Governor's Office of Health Policy and Finance and other stakeholders, to examine and make recommendations for hospital data reporting that will provide transparency concerning operating expenses, including, but not limited to, annual operating budgets and other financial information. The resolve requires the Maine Health Data Organization and the Governor's Office of Health Policy and Finance to submit a report to the Joint Standing Committee on Health and Human Services by January 1, 2010. It authorizes the Joint Standing Committee on Health and Human Services to submit legislation to the Second Regular Session of the 124th Legislature.
