COMMITTEE AMENDMENT "A" to H.P. 596, L.D. 865, Bill, "An Act To Change the Maine HIV Advisory Committee"

Amend the bill by striking out everything after the enacting clause and before the summary and inserting the following:

'Sec. 1. 5 MRSA §19202, sub-§1-A, as enacted by PL 1999, c. 390, §2 and affected by §10, is repealed.

Sec. 2. 5 MRSA §19202, sub-§1-B is enacted to read:

1-B. Duties. The Maine HIV Advisory Committee, as established in section 12004-I, subsection 42 and referred to in this section as "the committee," on behalf of those individuals infected by, at risk for or affected by the human immunodeficiency virus, referred to in this section as "HIV," in the State, shall:

- A. Advise the Office of the Governor and state, federal and private sector agencies, officials and committees on HIV-related and AIDS-related policy, planning, budget or rules;
B. Make an annual assessment of emerging HIV-related issues and trends;
C. Initiate and respond to legislation, both state and federal; and
D. Prepare and present, in person, an annual report on the status of HIV in the State to the Office of the Governor and the joint standing committee of the Legislature having jurisdiction over health and human services matters by January 31st of each year.

Sec. 3. 5 MRSA §19202, sub-§2-A, as enacted by PL 1999, c. 390, §4 and affected by §10 and amended by PL 2001, c. 354, §3 and PL 2003, c. 689, Pt. B, §§6 and 7, is repealed.

Sec. 4. 5 MRSA §19202, sub-§2-B is enacted to read:

2-B. Membership. The committee consists of 19 members as provided in this subsection.

A. The committee includes 7 members as follows, of whom only the Legislators are voting members:

(1) Two members of the Legislature, one Senator nominated by the President of the Senate and one Representative nominated by the Speaker of the House of Representatives;

(2) The director of the HIV, STD and viral hepatitis program within the Department of Health and Human Services, Maine Center for Disease Control and Prevention;

(3) A representative of the Department of Education, nominated by the Commissioner of Education;

(4) A representative of the Department of Corrections, nominated by the Commissioner of Corrections;

(5) A representative of the Department of Health and Human Services, Office of Substance Abuse, nominated by the Commissioner of Health and Human Services; and

(6) A representative of the Department of Health and Human Services, Office of MaineCare Services, nominated by the Commissioner of Health and Human Services.

B. The committee shall identify 12 additional representatives for membership as described in this paragraph, with broad input from persons with HIV or at risk for HIV infection or from organizations with extensive participation of persons with HIV, organizations interested in and working on HIV and AIDS prevention and health, other community-based organizations providing HIV and AIDS services, rural health centers and the public:

(1) Three persons who have HIV/AIDS;

(2) Two health care professionals involved with HIV treatment and care issues;

(3) Two providers of HIV-related prevention or social services;

(4) One representative of a state HIV community planning group;

(5) One representative of the statewide AIDS alliance under section 19251, subsection 4;

(6) One representative of a statewide coordinating council for public health; and

(7) Two at-large representatives including but not limited to: homeless persons, high-risk groups, family planning, mental health, higher education, civil rights or disability rights.

Sec. 5. 5 MRSA §19202, sub-§3, as corrected by RR 2003, c. 2, §10, is amended to read:

3. Terms. The term of office of each voting member is 3 years; except that of the members first chosen by the membership committee pursuant to subsection 2-A, 1/3 must

1 be chosen for a term of one year, 1/3 for a term of 2 years and 1/3 for a term of 3 years;
2 members chosen after nomination by the Commissioner of Health and Human Services,
3 the Commissioner of Education, the Commissioner of Corrections or the Commissioner
4 of Public Safety nonvoting members serve during the nominating duration of the
5 commissioner's term of office; for the agency that each member represents and
6 Legislators serve during the term for which they were elected. The membership shall
7 annually elect a chair and vice-chair. The chair is the presiding member of the
8 committee. All vacancies must be filled for the balance of the unexpired term in the same
9 manner as original appointments.

10 **Sec. 6. 5 MRSA §19202, sub-§4**, as amended by PL 1999, c. 390, §7 and
11 affected by §10, is further amended to read:

12 **4. Meetings.** The committee shall meet at least 4 times a year and more frequently if
13 needed to respond to the duties of this committee as specified in subsection ~~1-A~~ 1-B.
14 Special meetings may be called by the chair and must be called at the request of the State
15 Epidemiologist, the Director of the Bureau of Health, the Director of Disease Control, the
16 Director of Sexually Transmitted Diseases Department of Health and Human Services,
17 Maine Center for Disease Control and Prevention or by 3 or more members of the
18 committee.

19 **Sec. 7. Transition.** Notwithstanding the appointment provisions of the Maine
20 Revised Statutes, Title 5, section 19202, subsection 2-B, those members of the Maine
21 HIV Advisory Committee on September 30, 2009 under former Title 5, section 19202,
22 subsection 2-A may continue to serve on the committee for the balance of their terms of
23 office as provided under Title 5, section 19202, subsection 3. Notwithstanding Title 5,
24 section 19202, subsection 3, a person who is not a member of the committee on
25 September 30, 2009 and who is appointed to the committee pursuant to Title 5, section
26 19202, subsection 2-B serves a 3-year term.

27 **Sec. 8. Effective date.** This Act takes effect October 1, 2009.'

28 SUMMARY

29 This amendment replaces the bill. It changes the duties of the Maine HIV Advisory
30 Committee by adding budgeting to the areas on which the committee advises the
31 Governor and other agencies and removing the annual assessment of budget proposals at
32 state agencies related to HIV. It also changes the date by which the committee must
33 report to the Governor and the Legislature from January 15th to January 31st. It reduces
34 the size of the committee from 21 members to 19. It changes the composition of the
35 committee membership to 2 members of the Legislature, 5 state agency representatives, 3
36 members that have HIV or AIDS, 2 health care professionals, 2 HIV-related prevention
37 or social services providers, a member of a state HIV community planning group, a
38 representative of the statewide AIDS alliance, a representative of a statewide coordinating
39 council for public health and 2 at-large members selected from certain specified groups.
40 Members who represent state agencies are nonvoting members and serve only for the
41 duration of the term of the commissioner of the agency each member represents. It
42 removes the names of positions and offices no longer used and updates them with current

names. It provides that those members currently serving on the committee continue to serve for the balance of their 3-year terms.
