Amend the amendment in section 3 in §2517-C in subsection 1 in paragraph E in the
2nd line (page 1, line 25 in amendment) by striking out the following: "6" and inserting
the following: '4'

Amend the amendment in section 3 in §2517-C in subsection 2 by striking out all of
paragraph C (page 2, lines 2 and 3 in amendment)

Amend the amendment in section 3 in §2517-C in subsection 2 by relettering the
paragraphs to read consecutively.

Amend the amendment in section 3 in §2517-C in subsection 3 in the first line (page
2, line 11 in amendment) by striking out the following: "and to restaurants"

Amend the amendment in section 3 in §2517-C in subsection 3 in the 3rd line (page
2, line 13 in amendment) by striking out the following: "or to a restaurant"

Amend the amendment in section 3 in §2517-C by striking out all of subsections 4
and 5 (page 2, lines 29 to 42 and page 3, lines 1 to 7 in amendment)

Amend the amendment in section 3 in §2517-C in subsection 7 by striking out all of
the 2nd sentence (page 3, lines 12 to 17 in amendment)

Amend the amendment in section 3 in §2517-C by renumbering the subsections to
read consecutively.

Amend the amendment by striking out all of section 5 (page 3, lines 31 to 40 and
page 4, lines 1 and 2 in amendment)

Amend the amendment by inserting at the end before the summary the following:

'Amend the bill by relettering or renumbering any nonconsecutive Part letter or
section number to read consecutively.'

Fiscal Detail and Notes

The amendment eliminates the need for an allocation of funds and a half-time position for the Maine Center for Disease Control and Prevention in the Department of Health and Human Services, leaving minor costs that can be absorbed utilizing existing budgeted resources.
