11 12 13	Amend the bill in section 1 in §4611 in the first paragraph in the 4th line (page 1, line 8 in L.D.) by striking out the following: "such complaints" and inserting the following: 'such complaints a complaint'
14 15 16	Amend the bill in section 2 in paragraph B in the last line (page 1, line 37 in L.D.) by striking out the following: "of the alleged act of discrimination" and inserting the following: 'after the complaint is filed with the commission'
17 18	Amend the bill in section 3 by striking out all of paragraph C (page 1, lines 40 to 42 in L.D.) and inserting the following:
19 20 21	'C. The action shall <u>must</u> be commenced not more than <u>either</u> 2 years after the act of unlawful discrimination complained of <u>or 90 days after any of the occurrences listed</u> <u>under section 4622, subsection 1, paragraphs A to D, whichever is later.</u> '
22	Amend the bill by inserting after section 3 the following:

29	SUMMARY
30 31	This amendment provides that complaints filed with the Maine Human Rights Commission may be notarized after filing.
32 33 34	This amendment revises the bill to provide that the commission must conclude its investigation of a complaint within 2 years after the complaint is filed with the commission.
