Director of Bureau of Parks and Lands authorized, but not directed, to convey certain minority interests in land in T12 R17 WELS, 16 17 Aroostook County. Resolved: That the Director of the Bureau of Parks and Lands within the Department of Conservation may by quitclaim deed without covenant, for 18 19 appraised fair market value, and on such other terms and conditions as the director may 20 direct, convey any and all minority interests in common undivided interests in lands 21 owned by the Bureau of Parks and Lands in T12 R17 WELS to any party. The minority 22 common undivided interests owned by the Bureau of Parks and Lands are estimated to be 23 approximately 1,006 unlocated acres; and be it further' 24 **SUMMARY** 25 This amendment requires that 2 of the transfers authorized in the resolve be conveyed 26 for appraised fair market value. These are the transfers authorized in the resolve to 27 convey access rights either by fee or by easement over land in the Town of Brownville in 28 Piscataquis County and to convey minority interests in common undivided interests in 29 land in T12 R17 WELS in Aroostook County. Appraisals are not required for the other 30 transactions authorized in the resolve.
