COMMITTEE AMENDMENT "H" to H.P. 809, L.D. 1170, Bill, "An Act To Ensure the Accuracy of Maine Election Results"

Amend the bill by striking out the title and substituting the following:

12 'Resolve, Directing the Secretary of State To Report on the Accuracy of Election **Results'** 13

Amend the bill by striking out everything after the title and inserting the following:

'Sec. 1. Secretary of State to examine recent election recounts. Resolved: That the Secretary of State shall examine the results of at least 20 recent election recounts and compare those results with the original vote totals announced for those elections. The Secretary of State shall include in this examination elections that were conducted using electronic vote tally machines and elections in which the ballots were handcounted; and be it further

21 Sec. 2. Report. Resolved: That the Secretary of State shall issue a report to the 22 Joint Standing Committee on Legal and Veterans Affairs no later than February 15, 2010 23 based on the examination under section 1 that lists the election night vote tally versus the 24 recount vote tally for the elections examined. The report must include any reasons 25 discovered for discrepancy, including failure to properly follow post-election procedures. 26 The report must make recommendations and suggest legislation that would establish a 27 formal system for comparing election night vote tallies to recount vote tallies to provide 28 ongoing information regarding the accuracy of election results in the State. The Joint 29 Standing Committee on Legal and Veterans Affairs is authorized to report out legislation 30 to the Second Regular Session of the 124th Legislature based on the information received in the report.'

SUMMARY

This amendment replaces the bill with a resolve directing the Secretary of State to examine recent election recounts and compare the election night vote tally with the recount vote tally for those elections. The Secretary of State is required to submit a
