12	Amend the resolve by inserting before section 1 the following:
13 14	'Emergency preamble. Whereas, acts and resolves of the Legislature do no become effective until 90 days after adjournment unless enacted as emergencies; and
15 16 17	Whereas, the Finance Authority of Maine has the necessary expertise an commercial lending experience to effectively manage and administer a promissory not relating to an indebtedness from Lincoln Paper and Tissue, LLC; and
18 19 20	Whereas, it is necessary to act swiftly to allow the Finance Authority of Maine to oversee this obligation to ensure that the operations of the mill properties are properly overseen; and
21 22 23 24	Whereas, in the judgment of the Legislature, these facts create an emergency within the meaning of the Constitution of Maine and require the following legislation a immediately necessary for the preservation of the public peace, health and safety; now therefore, be it'

Amend the resolve by adding at the end before the summary the following:

'Emergency clause. In view of the emergency cited in the preamble, this legislation takes effect when approved.'

This amendment adds an emergency preamble and emergency clause to the resolve.
