The Treasurer of State shall reimburse the sponsor \$20,000 of the original payment from the Highway Fund after the issuance of the first 2,000 registration plates under this section.

Revenue in the fund must be used to provide financial assistance to members of the Maine National Guard, residents of the State who are members of the Reserves of the Armed Forces of the United States and the families of those members of the Maine National Guard or Reserves of the Armed Forces of the United States for emergencies and other special needs as determined by the We Support Our Troops Advisory Board established in Title 5, section 12004 I, subsection 84-A.

### §158. Maine Military Family Relief Fund

14 The Maine Military Family Relief Fund, referred to in this section as "the fund," is 15 established as a nonlapsing fund in the department administered according to rules 16 adopted by the Adjutant General. The Except as provided in subsection 1, the Adjutant 17 General is authorized to make award loans and grants from the Maine Military Family 18 Relief Fund fund for emergencies and other special needs to members or families of 19 persons who are members of the Maine National Guard or residents of the State who are 20 members or families of members of the Reserves of the Armed Forces of the United 21 States who have been called to military duty and to distribute funds to a statewide 22 nonprofit organization established for the purpose of providing assistance to members or 23 families of members of the Maine National Guard or residents of the State who are 24 members or families of members of the Reserves of the Armed Forces of the United 25 States. The Military Bureau shall adopt rules establishing eligibility criteria for the loans 26 and grants. Rules adopted pursuant to this section are routine technical rules as defined in 27 Title 5, chapter 375, subchapter 2-A.

1. We Support Our Troops Advisory Board. The We Support Our Troops
Advisory Board, as established by Title 5, section 12004-I, subsection 84-A and referred
to in this subsection as "the board," shall determine the use of the revenue in the fund that
is attributable to the issuance and renewal of the We Support Our Troops registration
plates established in Title 29-A, section 456-D. The board consists of 9 members:

- 33A. Eight members appointed by the Governor, in consultation with the Adjutant34General:
- 35 (1) Two persons, each representing the interests of the Maine National Guard;
- 36(2) Two persons, each representing the interests of Maine residents in the37Reserves of the Armed Forces of the United States; and
- 38 (3) Four persons representing the interests of the public; and
- 39 <u>B. The Adjutant General.</u>

40 <u>The Adjutant General serves during the Adjutant General's term of office.</u> The terms of 41 members appointed under paragraph A are for 3 years. Members may be reappointed for

subsequent terms. A vacancy must be filled in the same manner as an original appointment for the remainder of the unexpired term.

The board shall submit a report to the joint standing committee of the Legislature having jurisdiction over transportation matters by June 30th of each year. The report must provide a detailed account of funds for each fiscal year and include the number of loans and grants awarded, the names of those who received loans and grants, a description of the process for awarding loans and grants and the total amount of loan and grant money awarded.

**Sec. 7. Transition.** Notwithstanding the appointment provisions of the Maine Revised Statutes, Title 37-B, section 158, subsection 1, the members of the We Support Our Troops Advisory Board on June 30, 2010 under former Title 29-A, section 456-D, subsection 8 continue to serve on the board for the balance of their terms of office.'

### SUMMARY

14The committee amendment strikes and replaces the bill. The amendment directs that15proceeds from the sale of We Support Our Troops registration plates be deposited into the16Maine Military Family Relief Fund in the Department of Defense, Veterans and17Emergency Management. The amendment specifies that the We Support Our Troops18Advisory Board determines the use of the revenue deposited in the fund from the We19Support Our Troops registration plates.
