**RESOLUTION, Proposing an Amendment to the Constitution of** Maine To Reduce the Size of the House of Representatives

Resolved:** Two thirds of each branch of the 2 Legislature concurring, that the following amendment to the Constitution of Maine be 3 proposed:

Constitution, Art. IV, Pt. First, §2 is amended to read:

5 Section 2. Number of Representatives; biennial terms; division of the State into districts for House of Representatives. The House of Representatives 6 shall consist of 151 members, except that, for the Legislature that convenes in 2015 and 7 8 thereafter, the House of Representatives shall consist of 131 members, to be elected by the qualified electors, and hold their office 2 years from the day next preceding the first 9 Wednesday in December following the general election. The Legislature which convenes 10 in 1983 and every 10th year thereafter shall cause the State to be divided into districts for 11 12 the choice of one Representative for each district. The number of Representatives shall 13 be divided into the number of inhabitants of the State exclusive of foreigners not 14 naturalized according to the latest Federal Decennial Census or a State Census previously ordered by the Legislature to coincide with the Federal Decennial Census, to determine a 15 16 mean population figure for each Representative District. Each Representative District shall be formed of contiguous and compact territory and shall cross political subdivision 17 18 lines the least number of times necessary to establish as nearly as practicable equally populated districts. Whenever the population of a municipality entitles it to more than 19 20 one district, all whole districts shall be drawn within municipal boundaries. Anv 21 population remainder within the municipality shall be included in a district with 22 contiguous territory and shall be kept intact.

Constitutional referendum procedure; form of question; effective date. Resolved: That the municipal officers of this State shall notify the inhabitants of their respective cities, towns and plantations to meet, in the manner prescribed by law for holding a statewide election, at a statewide election held in the month of November 2012 following the passage of this resolution, to vote upon the ratification of the amendment proposed in this resolution by voting upon the following question:

"Do you favor amending the Constitution of Maine to reduce the size of the House of
Representatives from 151 members to 131 members effective in the year 2015?"

32 The legal voters of each city, town and plantation shall vote by ballot on this question and designate their choice by a cross or check mark placed within the corresponding 33 square below the word "Yes" or "No." The ballots must be received, sorted, counted and 34 35 declared in open ward, town and plantation meetings and returns made to the Secretary of State in the same manner as votes for members of the Legislature. The Governor shall 36 37 review the returns. If it appears that a majority of the legal votes are cast in favor of the amendment, the Governor shall proclaim that fact without delay and the amendment 38 39 becomes part of the Constitution of Maine on the date of the proclamation; and be it 40 further

Secretary of State shall prepare ballots. Resolved: That the Secretary of State
 shall prepare and furnish to each city, town and plantation all ballots, returns and copies
 of this resolution necessary to carry out the purposes of this referendum.

## **SUMMARY**

5 This resolution proposes to amend the Constitution of Maine to reduce the size of the 6 House of Representatives from 151 members to 131 members. The proposal would be 7 presented to the voters for their approval in November 2012, and after voter approval the 8 Legislature that convenes in 2013 would submit a reapportionment plan to implement the 9 reduction in the size of the House of Representatives. The reduction in the size of the 10 House of Representatives would take effect in 2015.
