Fiscal Detail and Notes

Increasing the potato tax by \$.01 per hundredweight will increase Other Special Revenue Funds revenue to the Maine Potato Board by \$113,899 in fiscal year 2011-12 and \$136,679 in fiscal year 2012-13 and beyond. The increased revenue has been projected based upon the average actual revenue collections for the last two fiscal years.
