An Act To Repeal Laws Prohibiting Certain Businesses from Operating on Sunday

(EMERGENCY)

1 **Emergency preamble.** Whereas, acts and resolves of the Legislature do not
2 become effective until 90 days after adjournment unless enacted as emergencies; and

3 **Whereas,** certain businesses in Maine are not allowed to operate on Sunday, placing
4 them at an economic disadvantage; and

5 **Whereas,** current economic realities require that business owners be allowed to
6 operate on Sunday to contribute to the recovery of Maine's economy; and

7 **Whereas,** in the judgment of the Legislature, these facts create an emergency within
8 the meaning of the Constitution of Maine and require the following legislation as
9 immediately necessary for the preservation of the public peace, health and safety; now,
10 therefore,

11 **Be it enacted by the People of the State of Maine as follows:**

12 **Sec. 1. 8 MRSA §268, first ¶,** as amended by PL 1999, c. 394, §1, is further
13 amended to read:

14 The commission shall adopt rules for holding, conducting and operating all harness
15 horse races or meets for public exhibition held in this State and for the operation of
16 racetracks on which any such race or meet is held; ~~notwithstanding any other provision of~~
17 ~~law, harness horse races or meets licensed to be held on Sunday may commence at, but~~
18 ~~not before, noon.~~

19 **Sec. 2. 14 MRSA §705,** as amended by PL 1995, c. 694, Pt. D, §15 and affected

2 B. Licensees may sell liquor on January 1st of any year from 12 midnight to 2 a.m.

3 (1) ~~In areas in which liquor may be sold except on Sundays, if January 1st falls~~
4 ~~on a Monday, licensees may sell or deliver liquor between 9 p.m. Sunday,~~
5 ~~December 31st and 2 a.m. January 1st, notwithstanding any local option~~

7 D. Wholesale licensees may sell or deliver liquor to licensed establishments from 4
8 a.m. on any day until 1 a.m. the following day.

23 authorize the State to permit the operation of state liquor stores and agency liquor stores
24 ~~on days other than Sunday?~~

25 **2-A. Sale of malt liquor and wine for consumption off the premises.** Shall this
26 municipality authorize the State to issue licenses for the sale of malt liquor and wine to be
27 consumed off the premises of licensed establishments ~~on days other than Sunday?~~

28 ~~**3. Sale of liquor for consumption on the premises on Sundays.** Shall this~~
29 ~~municipality authorize the State to issue licenses for the sale of liquor to be consumed on~~
30 ~~the premises of licensed establishments on Sundays?~~

32 ~~municipality authorize the State to permit the operation of state liquor stores and agency~~

35 ~~Shall this municipality authorize the State to issue licenses for the sale of malt liquor and~~

1 **Sec. 11. 28-A MRSA §353**, as amended by PL 1997, c. 373, §40, is further
2 amended to read:

3 **§353. Business hours**

4 State liquor stores and agency liquor stores may be open for the sale and delivery of
5 liquor between the hours of 6 a.m. and 1 a.m. in municipalities and unincorporated places
6 that have voted in favor of the operation of state liquor stores under local option
7 provisions. ~~Notwithstanding any local option decisions to the contrary, state liquor stores~~
8 ~~and agency liquor stores may be open from 9 a.m. Sunday to 1 a.m. the next day.~~ The
9 alcohol bureau shall establish the hours of operation of each state liquor store.

37 **Emergency clause.** In view of the emergency cited in the preamble, this
38 legislation takes effect when approved.
