1 **Be it enacted by the People of the State of Maine as follows:**

2 **Sec. 1. 21-A MRSA §671, sub-§1,** as amended by PL 2005, c. 453, §55, is
3 further amended to read:

4 **1. Name announced.** A voter who wishes to vote must provide proof of identity
5 with photograph identification documentation approved by the Secretary of State by rule
6 and state the voter's name and, upon request, residence address to an election clerk, who
7 shall announce the name in a loud, clear voice.

8 **Sec. 2. Rules.** The Secretary of State shall adopt rules establishing a photograph
9 identification standard for a voter providing proof of identity to an election clerk. Rules
10 adopted pursuant to this section are routine technical rules as defined in the Maine
11 Revised Statutes, Title 5, chapter 375, subchapter 2-A.

12 **SUMMARY**

13 This bill requires that a voter provide proof of identity with photograph identification
14 approved by the Secretary of State by rule for the purpose of voting.
