22 23 24 25 26 27 28 29	This amendment clarifies that the member of the stakeholder group established by the resolve invited to represent Maine's private higher education institutions represents private, nonprofit higher education institutions. The amendment strikes the provision inviting a Legislator serving on the Joint Standing Committee on Education and Cultural Affairs during the 125th Legislature. The amendment also provides that the Joint Standing Committee on Education and Cultural Affairs may introduce a bill during the Second Regular Session of the 125th Legislature to implement the recommendations on matters relating to the stakeholder group's review of the Maine State Grant Program.
