The Department of Agriculture Food and Rural Resources, Board of Pesticides Control, referred to in this section as "the board," shall amend Rule Chapter 28, Section 1 to establish a distance of 1,320 feet i pesticides are being applied using aircraft and 500 feet if being applied using air-carrie equipment from a sensitive area within which a person is entitled to receive notification of the application.
